25 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

26 Section 1. (a) Commencing June 1, 2026, the Sheriff of
27 St. Clair County, in addition to the compensation the sheriff
28 received on May 31, 2026, shall receive an additional expense

29 allowance in an amount that brings the sheriff's total annual
30 compensation to one hundred sixty thousand dollars (\$160,000).

31 (b) Commencing January 18, 2027, the total base annual
32 salary for the sheriff shall be one hundred sixty thousand
33 dollars (\$160,000), in lieu of all other expense allowances
34 and other forms of compensation.

35 Section 2. Commencing June 1, 2026, the total base
36 annual salary of the Judge of Probate of St. Clair County
37 shall be one hundred thirty thousand dollars (\$130,000), in
38 lieu of all other expense allowances and other forms of
39 compensation.

40 Section 3. (a) Commencing June 1, 2026, the Revenue
41 Commissioner of St. Clair County, in addition to the
42 compensation the revenue commissioner received on May 31,
43 2026, shall receive an additional expense allowance in an
44 amount that brings the revenue commissioner's total annual
45 compensation to one hundred thirty thousand dollars
46 (\$130,000).

47 (b) Commencing October 1, 2027, the total base annual
48 salary for the revenue commissioner shall be one hundred
49 thirty thousand dollars (\$130,000), in lieu of all other
50 expense allowances and other forms of compensation.

51 Section 4. (a) Commencing June 1, 2026, the Chair of
52 the St. Clair County Commission, in addition to the
53 compensation the chair received on May 31, 2026, shall receive
54 an additional expense allowance in an amount that brings the
55 chair's total annual compensation to one hundred thirty
56 thousand dollars (\$130,000).

57 (b) Commencing November 11, 2026, the total base annual
58 salary for the chair shall be one hundred thirty thousand
59 dollars (\$130,000), in lieu of all other expense allowances
60 and other forms of compensation.

61 Section 5. (a) Commencing June 1, 2026, each non-chair
62 member of the St. Clair County Commission, in addition to the
63 compensation each member received on May 31, 2026, shall
64 receive an additional expense allowance in an amount that
65 brings each member's total annual compensation to forty-five
66 thousand dollars (\$45,000).
