2 ENROLLED, An Act,

3 To make an appropriation of \$254,375 from the
4 Education Trust Fund to Lyman Ward Military Academy in Camp
5 Hill, Alabama for the support and maintenance of the
6 educational program of the institution, for the fiscal year
7 ending September 30, 2011; to provide that the appropriation
8 is subject to certain provisions of the Code of Alabama 1975;
9 to require an operations plan and an audited financial
10 statement prior to the release of any funds; and to require an
11 end of year report.

12 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

13 Section 1. There is hereby appropriated the sum of
14 \$254,375 from the Education Trust Fund to Lyman Ward Military
15 Academy in Camp Hill, Alabama for the support and maintenance
16 of the educational program of the institution, for the fiscal
17 year ending September 30, 2011.

18 Section 2. The above appropriation is made for the
19 support of public education in Alabama and for the support and
20 maintenance of the above program. The appropriation shall be
21 subject to the provisions, terms, conditions, and limitations
22 of the Budget and Financial Control Act, Code of Alabama 1975,
23 Sections 41-4-80 et seq.; the provisions of The Budget
24 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
25 et seq.; and any other provisions of this act.

1 Section 3. (a) Prior to the release of any funds
2 appropriated under this act the following reports shall be
3 submitted:

4 (1) An operations plan for the fiscal year
5 2010-2011, including goals and measurable performance
6 indicators, shall be submitted to and approved by the Director
7 of Finance, as provided for state agencies in Code of Alabama
8 1975, Section 41-19-10.

9 (2) An audited financial statement for all
10 operations during the fiscal year 2008-2009.

11 (b) It is the intent that funds appropriated for
12 fiscal year 2010-2011 shall be released by the Director of
13 Finance following receipt of the above reports.

14 (c) In addition, quarterly reports shall be made to
15 the Director of Finance relating actual expenditures and
16 accomplishments to planned expenditures and accomplishments.
17 An end of year performance report for the fiscal year
18 2010-2011 shall be made to the Director of Finance stating the
19 work accomplished and the services provided and the costs of
20 accomplishing the work and providing the services, citing
21 meaningful measures of program effectiveness and costs, as is
22 required for state agencies in Code of Alabama 1975, Section
23 41-19-11.

1 (d) The Director of Finance shall forward a copy of
2 all required reports to the Joint Fiscal Committee in a timely
3 manner.

4 Section 4. This act shall become effective October
5 1, 2010.
