8	To amend Sections 41-9-410, 41-9-411, and 41-9-413,
9	Code of Alabama 1975, and to add Sections 41-9-415 and
10	41-9-416 to the Code of Alabama 1975, relating to the Women's
11	Commission, to alter the duties, responsibilities,
12	qualifications, funding, and terms of office of members of the
13	Women's Commission.
14	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
15	Section 1. Sections 41-9-410, 41-9-411, and
16	41-9-413, Code of Alabama 1975, are amended to read as
17	follows:
18	"§41-9-410.
19	"There is hereby created and established a
20	continuing Women's Commission, hereinafter referred to as the
21	commission, which shall be composed of three members of the
22	House of Representatives appointed by the Speaker of the
23	House, two members of the Senate appointed by the President
24	Pro Tem of the Senate and 10 members appointed by the
25	Governor. Of those members appointed by the governor, one
26	member shall be appointed from each congressional district as

1 the same are established on September 20, 1971, and two members shall be appointed from the state-at-large. At least seven of the members appointed by the Governor shall be women. 3 The five members representing the Legislature shall be appointed for terms of two years, and their successors shall 5 be appointed for terms of two years. Of those members 6 7 appointed by the Governor, five members shall be appointed for terms of five years, and five members shall be appointed for 8 9 terms of three years, and the successors to such 10 appointees 10 shall serve for terms of three five years.

"Members shall be selected on the basis of their interests and knowledge in, and their ability to make contributions to, the solutions of problems related to the status of women.

"The commission shall report to the Governor and the Legislature.

"Vacancies on the commission shall be filled by appointment in the same manner provided for the appointment of the initial members. Any appointment to replace a member whose position becomes vacant prior to the expiration of the term shall be filled only for the remainder of the term.

"Members of the commission shall receive no compensation for their services, except that they may be reimbursed for reasonable and necessary expenses incident to their duties as members of the commission, in accordance with state law.

"The commission shall hold an organizational session at which time the commission shall select a chairman and such other officers from its membership as it deems necessary. The commission shall at its organizational session adopt such procedures and rules that will enable the implementation of the purposes of the commission. It shall have the responsibility of appointing such committees and task forces as they deem necessary. Members of such committees shall serve without compensation. It shall be provided with office space and necessary office equipment. It may engage employees and consultants, hold public hearings and generate other activities as may be needed to realize the purposes of the commission.

"The commission shall be a continuing vehicle for the determination of effective policy and legislation in the areas which will affect Alabama's women. It shall study the status of women in this state and make recommendations to the Governor and Legislature for constructive action in the following areas:

- "(1) Public and private employment policies and practices;
- "(2) Labor laws dealing with hours, wages and
  working conditions;
  - "(3) Legal rights and responsibilities;

2	education, counseling and job training;
3	" <del>(5) Citizen volunteers; and</del>
4	" <del>(6) Home and community.</del>
5	"The purpose of the commission is to improve and
6	advance the lives of women in the State of Alabama. The
7	commission may study, make recommendations, educate, and
8	promote constructive action on issues related to women which
9	shall include, but not be limited to, economic development,
10	education, employment, health, legal rights, political
11	participation, and the quality of individual and family life.
12	The areas of responsibility may include any or all of the
13	<pre>following:</pre>
14	"(1) To create public awareness and understanding of
15	the responsibilities, needs, potentials, and contributions of
16	women and their roles in the changing society.
17	"(2) To research, assemble, analyze, and disseminate
18	pertinent data and educational materials relating to
19	activities and programs which will assist in meeting the needs
20	of women.
21	"(3) To institute, conduct, and/or support
22	educational and other programs, meetings, conferences,
23	hearings, forums, and discussion groups to address matters of
24	concern to the women of the state.

1	"(4) To advise and make recommendations to the
2	Governor and to the Legislature on issues, policies, and
3	programs relating to women.
4	"(5) To evaluate and monitor legislation pending in
5	the Legislature on issues relating to women and make
6	recommendations concerning such legislation to the Governor
7	and the Legislature.
8	"(6) To maintain contact and collaborate with the
9	appropriate federal, state, local, and international agencies
10	concerned with the status of women.
11	"(7) To perform such other functions and duties as
12	imposed upon it by law or as are assigned to it by the
13	Governor or the Legislature, or both."
14	Section 2. Sections 41-9-415 and 41-9-416 are hereby
15	added to the Code of Alabama 1975, to read as follows:
16	§41-9-415.
17	(a) The commission may employ an executive director,
18	who shall serve at the pleasure of the commission and who
19	shall be responsible directly to the commission. The
20	commission shall determine the compensation of the executive
21	director which shall be paid from the funds of the commission.
22	The commission shall designate the duties and responsibilities
23	of the executive director.
24	(b) The commission may employ administrative
25	employees, consultants, research assistants, and other
26	supervisory and professional personnel as may be necessary or

advisable for carrying out in the most efficient and beneficial manner the purposes and provisions of this article. The commission may offer to its employees any benefits offered to employes of the State of Alabama, including retirement, medical and dental care, and workers' compensation plans.

- (a) The commission shall administer funds allocated for its work and be authorized to accept, disburse, and allocate any funds that may become available from other governmental and private sources, provided that all such funds shall be disbursed or allocated in compliance with any specific designation stated by the donor. In the absence of such specific designation, the funds shall be disbursed or allocated on projects related to any of the purposes of the commission.
- (b) The commission may impose user fees on participants in its programs, services, or activities. Fees shall not exceed the reasonable cost of administering the programs, services, or activities. The commission or the executive director may waive the user fee if the waiver would promote the purpose of the commission or the participant is unable to pay the user fee.
- (c) All user fees collected, sponsorships, direct appropriations, and other funds received shall be deposited into a special fund in the State Treasury to be known as the Women's Commission Fund. The commission may make deposits and

1 expenditures from such special fund to administer and implement the purposes of this article, including, but not limited to, expenditures for expenses, meals and receptions, 3 awards, and promotional items. All revenue remaining in the special fund at the end of the fiscal year shall carry over to 5 the next fiscal year and shall not revert to the State General 6 7 Fund or any other fund. Such funds shall be appropriated, budgeted and allotted in accordance with Sections 41-4-80 to 8 41-4-96, inclusive and 41-19-1 to 41-19-12, inclusive and only 9 10 in amounts stipulated in general appropriations bills and 11 other appropriations bills.

- (d) All contributions and gifts of money and property made to the commission shall be exempt from all taxation in the state. All real and personal property, money, income, resources, and activities of the commission shall be exempt from all taxation in the state.
- (e) The commission may award research grants in accordance with state law and subject to budget appropriations.
- (f) The commission shall maintain accurate records and books of account covering revenue and expenditures, which shall be subject to audit by the Department of Examiners of Public Accounts.
- (g) The commission shall be provided with office space and necessary office equipment.

Section 3. This act shall become effective immediately following its passage and approval by the Governor, or its otherwise becoming law.
