9		cutting, removal, transportation, sale, or purchase
10		of timber and other forest products is a
11		misdemeanor.
12		This bill would specify that these offenses
13		are Class A misdemeanors.
14		This bill would also make it a crime to
15		alter a weight measuring device or otherwise cause
16		a weight measuring device to give a false reading
17		of forest products.
18		This bill would define forest products.
19		Amendment 621 of the Constitution of Alabama
20		of 1901, now appearing as Section 111.05 of the
21		Official Recompilation of the Constitution of
22		Alabama of 1901, as amended, prohibits a general
23		law whose purpose or effect would be to require a
24		new or increased expenditure of local funds from
25		becoming effective with regard to a local
26		governmental entity without enactment by a 2/3 vote
27		unless: it comes within one of a number of

specified exceptions; it is approved by the affected entity; or the Legislature appropriates funds, or provides a local source of revenue, to the entity for the purpose.

The purpose or effect of this bill would be to require a new or increased expenditure of local funds within the meaning of the amendment. However, the bill does not require approval of a local governmental entity or enactment by a 2/3 vote to become effective because it comes within one of the specified exceptions contained in the amendment.

AN ACT

To amend Section 9-13-60, Code of Alabama 1975, to provide further for penalties related to crimes involving timber and forest products; to make it a crime to cause a weight measuring device to give a false reading of timber or forest products; to define forest products; and in connection therewith would have as its purpose or effect the requirement of a new or increased expenditure of local funds within the meaning of Amendment 621 of the Constitution of Alabama of 1901, now appearing as Section 111.05 of the Official Recompilation of the Constitution of Alabama of 1901, as amended.

1	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:		
2	Section 1. Section 9-13-60, Code of Alabama 1975, is		
3	amended to read as follows:		
4	" §9-13-60.		
5	" <u>(a)</u> Any <u>It is unlawful for any</u> person or persons		
6	who shall to do any of the following:		
7	"(1) Willfully and knowingly cut, kill, destroy,		
8	girdle, chop, chip, saw or otherwise damage timber or forest		
9	products not his own or without authority of the legal owner $ au_{ au_{-}}$		
10	"(2) Willfully and knowingly remove timber or other		
11	forest products other than his own or without authority of the		
12	legal owner;.		
13	"(3) Willfully and knowingly transport timber or		
14	other forest products which have been severed or removed in		
15	violation of subdivisions (1) or (2) of this section $\frac{1}{7}$.		
16	(4) Willfully and knowingly purchase or contract to		
17	purchase or otherwise obtain timber or forest products		
18	severed, removed or transported in violation of subdivisions		
19	(1), (2) or (3) of this section; and,.		
20	"(5) Willfully and knowingly sell, contract to sell		
21	or otherwise dispose of logs, poles, piling, crossties,

25	"(6) Alter or by any means cause a weight measuring

7	"(b) A violation of subsection (a) is a Class A		
8	misdemeanor and shall be punished as provided by law.		
9	"(c) The term "forest products" includes, but is not		
10	limited to, timber, trees, logs, lumber, pine straw, woody		
11	biomass, or any other products in the forest which are located		
12	on any land in this state, whether publicly or privately		
13	owned."		
14	Section 2. Although this bill would have as its		
15	purpose or effect the requirement of a new or increased		
16	expenditure of local funds, the bill is excluded from further		
17	requirements and application under Amendment 621, now		
18	appearing as Section 111.05 of the Official Recompilation of		
19	the Constitution of Alabama of 1901, as amended, because the		
20	bill defines a new crime or amends the definition of an		
21	existing crime.		
22	Section 3. This act shall become effective on the		
23	first day of the third month following its passage and		
24	approval by the Governor, or its otherwise becoming law.
