9 A BILL  
10 TO BE ENTITLED  
11 AN ACT  
12

13 To alter, rearrange, and extend the boundary lines  
14 and corporate limits of the municipality of Lake View in  
15 Tuscaloosa County; to add certain property to the municipality  
16 of Lake View; to make certain findings in regard to the public  
17 necessity for the annexation; and to provide that the  
18 municipality shall exercise full authority over the annexed  
19 territory.

20 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

21 Section 1. The Legislature hereby finds and  
22 determines that it is expedient, wise, necessary, proper, and  
23 in the best interests of the citizens of the State of Alabama,  
24 Tuscaloosa County, and the municipality of Lake View to alter,  
25 rearrange, and extend the corporate limits of the municipality  
26 of Lake View as herein provided, including, but not limited  
27 to, the purpose of generally promoting the welfare of the

1 State of Alabama, Tuscaloosa County, and the municipality of  
2 Lake View and specifically, but not limited to, the initial  
3 purpose of facilitating the municipality of Lake View in  
4 providing certain services to the area to be annexed which is  
5 the municipality of Lake View municipal complex. Provided,  
6 however, the foregoing shall not be construed to limit in any  
7 manner or otherwise curtail the exercise of any municipal  
8 powers and authorities by the municipality of Lake View and  
9 shall not prohibit future or subsequent annexations in  
10 accordance with the provisions hereof and the laws of the  
11 state.

12 Section 2. The boundary lines and corporate limits  
13 of the municipality of Lake View in Tuscaloosa County are  
14 altered, rearranged, extended, and redefined to include within  
15 the corporate limits of the municipality, in addition to the  
16 lands now included, all of the territory below described in  
17 Tuscaloosa County, Alabama:

18 (PARCEL ONE-Municipal Complex) A parcel of land  
19 situated in the NE 1/4 Section 29, Township 20 South, Range 5  
20 West, Tuscaloosa County, Alabama, and being more particularly  
21 described as Commence at the NE corner of Section 29, Township  
22 20 South, Range 5 West, Tuscaloosa County, Alabama; thence  
23 S41°03'57"W, a distance of 2,411.73'; thence S26°28'08"E, a  
24 distance of 103.14' to the POINT OF BEGINNING; thence continue  
25 southeasterly along said line, a distance of 131.98' to a  
26 point of curve to the left having a radius of 325.00' and a  
27 central angle of 16°22'47", said curve subtended by a chord

1 bearing S34°39'31"E and a chord distance of 92.59'; thence  
2 southeasterly along the arc of said curve a distance of 92.91'  
3 to a point of reverse curve having a radius of 15.00' and a  
4 central angle of 83°14'37", said curve subtended by a chord  
5 bearing S01°13'36"E and a chord distance of 19.93'; thence  
6 southerly along the arc along the arc of said curve, a  
7 distance of 21.79'; thence S40°23'42"W, a distance of 168.73'  
8 to a point of curve to the right having a radius of 150.00'  
9 and a central angle of 11°52'25", said curve subtended by a  
10 chord bearing S46°19'54"W and a chord distance of 31.03';  
11 thence southwesterly along the arc of said curve a distance of  
12 31.09'; thence N24°23'16"W, a distance of 73.00'; thence  
13 N79°44'10"W, a distance 24.78'; thence S65°36'44"W, a distance  
14 of 42.87', thence N69°44'04"W, a distance of 219.97'; thence  
15 N36°09'13"W, a distance of 141.41' to the point of curve of a  
16 non tangent curve to the left, having a 39°01'41" of and a  
17 radius of 175.00', said curve subtended by a chord bearing  
18 N64°32'16"E and a chord distance of 116.91': thence  
19 northeasterly along the arc of said curve a distance of  
20 119.20': thence N45°01'25"E, a distance of 123.98' to a point  
21 of curve to the right having a radius of 175.00' and a central  
22 angle of 18°30'28", said curve subtended by a chord bearing  
23 N54°16'39"E and a chord distance of 56.28'; thence  
24 northeasterly along the arc of said curve a distance of  
25 56.53'; thence S35°18'40"E, a distance of 119.56'; thence  
26 N63°31'52"E, a distance of 106.33' to the PARCEL TWO (STP) -  
27 Commence at the NE corner of the NW 1/4 of Section 28,

1 Township 20 South, Range 5 West, Jefferson County, Alabama and  
2 run in a Southerly direction along the East line of said 1/4  
3 Section a distance of 1271.91 feet to a point; thence deflect  
4 an angle of 90 degrees to the right and run in a Westerly  
5 direction a distance of 597.36 feet to the Point of Beginning  
6 of the herein described property; thence deflect 55 degrees  
7 11' 59" to the left and run in a Southerly direction a  
8 distance of 318.35 feet to a point; thence turn an interior  
9 angle of 177 degrees 18' 36" and run to the right in a  
10 Southwesterly direction a distance of 498.99 feet to a point;  
11 thence turn an interior angle of 70 degrees 23' 04", and run  
12 to the right in a Northwesterly direction a distance of 665.63  
13 feet to a point on the Southerly Right-of-way of the  
14 Norfolk-Southern Railroad and a point on a curve right having  
15 a central angle of 0 degrees 35' 31" and a Radius of 54,564.30  
16 feet; thence turn an interior angle of 111 degrees 15' 49" to  
17 the chord of said curve and run in a Northeasterly direction  
18 along the arc of the Right-of-Way of said Railroad a distance  
19 of 563.85 feet to a point; thence from the chord of said curve  
20 turn an interior angle of 91 degrees 02' 31" and leaving said  
21 Railroad Right-of-Way run in a Southeasterly direction a  
22 distance of 628.97 feet, more or less, to the Point of  
23 Beginning; said parcel containing 9.8 acres (+-).

24 PARCEL THREE (Petro) - Begin at the NE corner of the  
25 NW 1/4 of the SW 1/4 of Section 20, Township 20 South, Range 5  
26 19 West, Tuscaloosa County, Alabama, and run in a Southerly  
27 direction along the East line of said 1/4 - 1/4 Section a

1 distance of 1253.08 feet (1253.61' deed) to a point; thence  
2 deflect 60 degrees 58' 54" (61 degrees 01' deed) to the right  
3 and run in a Southwesterly direction a distance of 914.24 feet  
4 to a point; thence deflect 23 degrees 27' to the right and run  
5 in a Southwesterly direction a distance of 7.60 feet to a  
6 point on the North Right-of-Way line of Old Tuscaloosa  
7 Highway; thence deflect 13 degrees 04' to the right and run in  
8 a Northwesterly direction a distance of 206.83 feet along said  
9 right-of-way to a point on the right-of-way acquired for  
10 Interstate 59; thence deflect 2 degrees 02' 30" to the right  
11 and run in a Northwesterly direction along said Interstate 59  
12 a distance of 411.38 feet to a point; thence deflect 90  
13 degrees 48' to the right and run in a Northeasterly direction  
14 along said Interstate 59 right-of-way a distance of 60.05 feet  
15 to a point; thence deflect 87 degrees 45' to the left and run  
16 in a Northwesterly direction a distance of 292.40 feet along  
17 the right-of-way of Interstate 59 to a point; thence deflect  
18 46 degrees 25' 45" to the right and run in a Northwesterly  
19 direction a distance of 128.50 feet along the right-of-way of  
20 Interstate 59 to a point; thence deflect 55 degrees 57' 30" to  
21 the right and run in a Northeasterly direction a distance of  
22 697.10 feet along the right-of-way of Interstate 59 to a  
23 point; thence deflect 8 degrees 33' 30" to the right and run  
24 in a Northeasterly direction a distance of 205.20 feet along  
25 the right-of-way of Interstate 59 to a point; thence deflect  
26 11 degrees 44' to the right and run in a Northeasterly  
27 direction a distance of 131.88 feet along the right-of-way of

1 Interstate 59 to the point of beginning of a curve to the  
2 right having a central angle of 5 degrees 28' 51" and a radius  
3 of 7489.49 feet, and an arc of 716.42 feet; thence continue in  
4 a Northeasterly direction along the arc of said curve and  
5 along said Interstate 59 right-of-way a distance of 716.4  
6 feet, more or less, to a point of intersection of said  
7 right-of-way curve with the North line of said 1/4 - 1/4  
8 Section; thence deflect 39 degrees 42' 09" to the right from  
9 the tangent of last described curve and run along the North  
10 line of said 1/4 - 1/4 Section in an Easterly direction a  
11 distance of 724.90 feet, more or less, to the point of  
12 beginning; said parcel containing 49.56 acres (+-).

13 PARCEL FOUR (Loves -1) - Commence at a 3" iron pipe  
14 at the SW corner of the SE 1/4 of Section 19, Township 20  
15 South, Range 1 West, Tuscaloosa County, Alabama; thence run  
16 North 00 degrees 46' 34" West along the West boundary of the  
17 SE 1/4 of said Section 19 a distance of 1296.02 feet to a  
18 point of the South right-of-way of Alabama Hwy. No. 216  
19 (variable right-of-way); thence, run South 79 degrees 41' 42"  
20 East along said right-of-way a distance of 295.93 feet to a  
21 1/2" rebar and cap set at the point of curvature of a curve  
22 concave Northwardly, said curve having a radius of 7551.00  
23 feet and a delta angle left of 02 degrees 48' 38"; thence, run  
24 along said curve an arc distance of 370.41 feet to a point  
25 (the chord subtending said arc bearing South 81 degrees 06'  
26 01" East a distance of 370.38 feet) to the POINT OF BEGINNING;  
27 thence, continue along said curving right-of-way an arc

1 distance of 51.68 feet to a 1/2" rebar and cap set at the  
2 point of tangency of said curve (the curve subtending said arc  
3 bearing South 82 degrees 42' 06" East a distance of 51.68  
4 feet); thence, run South 82 degrees 53' 52" East along said  
5 right-of-way a distance of 247.39 feet to a 1/2" rebar and cap  
6 set at the intersection of the South right-of-way of said  
7 Alabama Hwy. No. 216 and the Northwest right-of-way of  
8 U.S.Interstate 20/59 (variable right-of-way); thence, run  
9 South 28 degrees 25' 01" West along the Northwest right-of-way  
10 of said Interstate Highway a distance of 578.38 feet to a  
11 concrete right-of-way monument found at centerline Station  
12 112+21.64; thence, run South 39 degrees 51' 06" West along  
13 said right-of-way a distance of 19.64 feet to an iron bar  
14 found; thence, depart said right-of-way and run North 00  
15 degrees 54' 42" West a distance of 560.99 feet to the POINT OF  
16 BEGINNING; said parcel containing 1.9 acres (+-).

17 PARCEL FIVE (Loves-2) Commence in a 3" iron pipe at  
18 the SW corner of the SE 1/4 of Section 19, Township 20 South,  
19 Range 1 West, Tuscaloosa County, Alabama, thence run North 00  
20 degrees 46' 34" West along the West boundary of the SE 1/4 of  
21 said Section 19 a distance of 1296.02 feet to a point on the  
22 South right-of-way of Alabama Hwy. No. 216 (variable  
23 right-of-way); thence, run South 79 degrees 41' 42" East  
24 along said right-of-way a distance of 191.21 feet to a 1/2"  
25 rebar and cap set at the POINT OF BEGINNING; thence, continue  
26 South 79 degrees 41' 42" East along said right-of-way a  
27 distance of 104.72 feet to a 1/2" rebar and cap set at the



1 Point of Curvature of a curve concave Northwardly, said curve  
2 having a radius of 7551.00 feet and a Delta angle left of 02  
3 23 degrees 48' 38"; thence run along said curve an arc  
4 distance of 370.41 feet to a point (the curve subtending said  
5 arc bearing South 81 degrees 06' 01" East a distance of 370.38  
6 feet); thence, depart said right-of-way, run South 00 degrees  
7 54' 42" East a distance of 373.99 feet to a 1/2" rebar and cap  
8 set; thence, run South 89 degrees 05' 18" West a distance of  
9 474.73 feet to a 1/2" rebar and cap set; thence run North 00  
10 degrees 01' 47" West a distance of 457.53 feet to the POINT OF  
11 BEGINNING; said parcel containing 4.47 acres.

12 Section 3. All territory brought within the  
13 corporate limits of the municipality of Lake View under the  
14 provisions of this act shall be subject to the laws and  
15 ordinances of the municipality, and the mayor and council  
16 shall have and exercise the same and exclusive jurisdiction  
17 over the territory as is presently exercised over the  
18 territory within the corporate limits of the municipality.

19 Section 4. The provisions of this act are severable.  
20 If any part of this act is declared invalid or  
21 unconstitutional, that declaration shall not affect the part  
22 which remains.

23 Section 5. All laws or parts of laws which conflict  
24 with this act are repealed.

25 Section 6. In accordance with Section 11-42-6(b) of  
26 the Code of Alabama 1975, a map showing what territory is  
27 proposed to be annexed to the municipality of Lake View is on

1 file in the office of the Judge of Probate in Tuscaloosa  
2 County, Alabama, and the map is open to the inspection of the  
3 public.

4 Section 7. This act shall become effective  
5 immediately following its passage and approval by the  
6 Governor, or its otherwise becoming law.
