ENROLLED, An Act,

Relating to the Town of Franklin in Macon County; to amend Act 2004-477, 2004 Regular Session (Acts 2004, p.883), altering, rearranging, and extending the corporate limits of the town, to correct certain clerical errors in the description; and to provide for retroactive effect.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 1 of Act 2004-477, 2004 Regular Session (Acts 2004, p.883), is amended to read as follows:

"Section 1. The boundary lines and corporate limits of the Town of Franklin in Macon County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

"(1) Tracts in Township 17 North, Range 23 East.

"Section 7,

"Section 8,

"Section 9 (less and except the North East 1/4 of the North West 1/4 and the East 1/2),

"Section 18 (less and except the South West 1/4 of the South West 1/4),

"Section 17,

"Section 16 (less and except the North East 1/4),

1           "Section 19 (less and except the West 1/2 of the  
2 East 1/2, the East 1/2 of the West 1/2, the North West 1/4 of  
3 the North West 1/4, the South West 1/4 of the North West 1/4,  
4 and the North West 1/4 of the South West 1/4),

5           "Section 20,

6           "Section 21 (less and except the South East 1/4 of  
7 the South East 1/4),

8           "Section 29,

9           "Section 30,

10          "Section 31 (less and except the South 1/2).

11          "(2) Tracts in Township 17 North, Range 22 East.

12          "Tracts to include: the North West 1/4 of the South  
13 West 1/4 and the South West 1/4 of the South West 1/4 (less  
14 and except that portion South of Macon County Road #9) all  
15 lying in Section 14.

16          "Tracts to include: the North West 1/4 of the North  
17 West 1/4, the South West 1/4 of the North West 1/4, the North  
18 East 1/4 of the North West 1/4, and the North West 1/4 of the  
19 South West 1/4 (less and except that portion South of  
20 Interstate Highway 85) all lying in Section 23.

21          "Tract to include the North East 1/4 of Section 22.

22          "Tracts to include: acreage currently within,

23          "tax parcel #46-09-05-15-0-000-32.000,

24          "tax parcel #46-09-05-0-000-36.000,

25          "tax parcel #46-09-05-15-0-000-20.008, and

1                   "tax parcel #46-09-05-15-0-000-20.009, all parcels  
2                   lying in Section 15."

3                   Section 2. This act is curative to correct clerical  
4                   errors and otherwise clarify that certain tracts in Township  
5                   17 North, Range 22 East are separate parcels in conformity  
6                   with the obvious intent of the Legislature based on the  
7                   location of the tracts.

8                   Section 3. This act is retroactive to August 1,  
9                   2004.
