WHEREAS, Alejandro Pena-Esclusa's knowledge and understanding of the foregoing issues and circumstances is unsurpassed in his field; his further insight into the nexus of Islamic terrorism, drug trafficking, and totalitarian expansionism, in Latin America and around the globe, is worthy of our attention and our praise; now therefore,
