11 WHEREAS, it is with great pleasure that highest
12 commendation is extended to Eumar Roberto Novacki; and

13 WHEREAS, Mr. Novacki is Lieutenant Colonel with the
14 Military Police of the State of Mato Grosso, Brazil, a rank he
15 has held since September 21, 2009; his rank is a reflection of
16 his commitment and dedication to serving the people of the
17 State of Mato Grosso; and

18 WHEREAS, Lieutenant Colonel Novacki also serves as
19 Secretary Chief of Staff of the Government of the State of
20 Mato Grosso; he has served the State of Mato Grosso with
21 distinction in numerous progressively responsible positions;
22 he has been recognized with honors and commendations too
