- 3 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$52,475,875 from the State General Fund to the Department of Corrections for operational costs for the fiscal year ending September 30, 2010.

Section 2. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$41,995,706 from the State General Fund to the Alabama Medicaid Agency for operational costs for the fiscal year ending September 30, 2010.

Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$100,000 from the State General Fund to the Department of Public Health for the establishment of a regional certified Amyotrophic Lateral Sclerosis (ALS) clinic for the fiscal year ending September 30, 2010.

Section 4. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$185,000 from the State General Fund to the Department of Environmental Management for the Pollution Control Grant Fund for the fiscal year ending September 30, 2010.

Section 5. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$110,000 from the State General Fund to the Alabama Supreme

1 Court for operational costs for the fiscal year ending 2 September 30, 2010. Section 6.
