Section 36-25-7, Code of Alabama 1975, as 8 SYNOPSIS: amended in the 2010 First Special Session by Act 9 10 No. 2010-764, prohibits a person from offering or 11 giving anything to a public official or public 12 employee, as well as members of their households or 13 family, for the purpose of influencing official 14 action. Similarly, this section prohibits a public 15 official or public employee, as well as members of their households or family, from soliciting or 16 17 receiving anything for the purpose of influencing 18 official action.

19 To alleviate questions relating to vagueness and enforceability, this bill would clarify that 20 21 the prohibited offer, gift, solicitation, or 22 receipt of anything, as contemplated in Section 36-25-7, Code of Alabama 1975, as amended in the 23 24 2010 First Special Session by Act No. 2010-764, 25 must be for the purpose of corruptly influencing official action. 26
