8 SYNOPSIS: Existing law provides provisions relating to
9 a durable power of attorney and gifts by a power of
10 attorney.

11 This bill would provide for the Alabama
12 Uniform Power of Attorney Act.

13 This bill would generally provide for
14 definitions and applicability; when a power of
15 attorney is durable and the execution, validity,
16 meaning, and effect of a power of attorney;
17 nomination of a conservator or guardian; and for
18 the relation of an agent to a court-appointed
19 fiduciary.

20 This bill would provide for when a power of
21 attorney is effective and for the termination of a
22 power of attorney or an agent's authority;
23 co-agents and successor agents; reimbursement and
24 compensation of an agent; an agent's acceptance and
25 duties; the exoneration of an agent; and judicial
26 relief.

1 This bill would provide for an agent's
2 liability to the principal; resignation and notice;
3 acceptance of and reliance upon an acknowledged
4 power of attorney; liability for refusal to accept
5 an acknowledged power of attorney; principles of
6 law and equity; laws applicable to financial
7 institutions and entities; and would provide
8 remedies under other law.

9 This bill would provide for the authority of
10 a power of attorney that requires specific grants
11 or a grant of general authority; incorporation and
12 construction of authority; the authority over real
13 property, tangible personal property, stocks and
14 bonds, commodities and options; the authority of
15 banks and other financial institutions; the
16 authority of operating an entity or business;
17 authority over insurance and annuities, estates,
18 trusts, and other beneficial interests; claims and
19 litigation; personal and family maintenance;
20 benefits from governmental programs or civil or
21 military service; retirement plans; taxes; and
22 gifts.

23 This bill would provide a power of attorney
24 form and a form of an agent's certification;
25 provide for uniformity of application and
26 construction; relation of this act to the
27 Electronic Signatures in Global and National

1 Commerce Act; the effect on existing powers of
2 attorney; and provide for health care powers of
3 attorney executed after the effective date of this
4 act.

5 This bill would also amend existing
6 provisions relating to a durable power of attorney.

9 TO BE ENTITLED
10 AN ACT
11

12 To add a new Chapter 1A of Title 26 of the Code of
13 Alabama 1975; to provide for the Alabama Uniform Power of
14 Attorney Act; to generally provide for definitions and
15 applicability; to provide for when a power of attorney is
16 durable; to provide for the execution, validity, meaning,
17 effect, and termination of a power of attorney; to provide for
18 the nomination of a conservator or guardian; to provide for an
19 agent, co-agents, and successor agents and duties of the
20 agent; to provide for the authority of a power of attorney; to
21 provide for an agent's liability to the principal; to provide
22 a power of attorney form and a form of an agent's
23 certification; to provide for the effect on existing powers of
24 attorney; to provide for health care powers of attorney
25 executed after the effective date of this act; and to amend
26 Section 26-1-2 of the Code of Alabama 1975, relating to a
27 durable power of attorney.

1 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

2 Section 1. The following new Chapter 1A is added to
3 Title 26 of the Code of Alabama 1975, to read as follows:

4 CHAPTER 1A. ALABAMA UNIFORM POWER OF ATTORNEY ACT

5 ARTICLE 1. GENERAL PROVISIONS

6 SECTION 26-1A-101. SHORT TITLE. This chapter may be
7 cited as the Alabama Uniform Power of Attorney Act.

8 SECTION 26-1A-102. DEFINITIONS. In this chapter:

9 (1) "Agent" means a person granted authority to act
10 for a principal under a power of attorney, whether denominated
11 an agent, attorney-in-fact, or otherwise. The term includes an
12 original agent, co-agent, successor agent, and a person to
13 which an agent's authority is delegated.

14 (2) "Durable," with respect to a power of attorney,
15 means not terminated by the principal's incapacity.

16 (3) "Electronic" means relating to technology having
17 electrical, digital, magnetic, wireless, optical,
18 electromagnetic, or similar capabilities.

19 (4) "Good faith" means honesty in fact.

20 (5) "Incapacity" means inability of an individual to
21 manage property or business affairs because the individual:

22 (A) has an impairment in the ability to receive and
23 evaluate information or make or communicate decisions even
24 with the use of technological assistance; or

25 (B) is:

26 (i) missing;

1 (ii) detained, including incarcerated in a penal
2 system; or

3 (iii) outside the United States and unable to
4 return.

5 (6) "Person" means an individual, corporation,
6 business trust, estate, trust, partnership, limited liability
7 company, association, joint venture, public corporation,
8 government or governmental subdivision, agency, or
9 instrumentality, or any other legal or commercial entity.

10 (7) "Power of attorney" means a writing or other
11 record that grants authority to an agent to act in the place
12 of the principal, whether or not the term power of attorney is
13 used.

14 (8) "Presently exercisable general power of
15 appointment," with respect to property or a property interest
16 subject to a power of appointment, means power exercisable at
17 the time in question to vest absolute ownership in the
18 principal individually, the principal's estate, the
19 principal's creditors, or the creditors of the principal's
20 estate. The term includes a power of appointment not
21 exercisable until the occurrence of a specified event, the
22 satisfaction of an ascertainable standard, or the passage of a
23 specified period only after the occurrence of the specified
24 event, the satisfaction of the ascertainable standard, or the
25 passage of the specified period. The term does not include a
26 power exercisable in a fiduciary capacity or only by will.

1 (9) "Principal" means an individual who grants
2 authority to an agent in a power of attorney.

3 (10) "Property" means anything that may be the
4 subject of ownership, whether real or personal, or legal or
5 equitable, or any interest or right therein.

6 (11) "Record" means information that is inscribed on
7 a tangible medium or that is stored in an electronic or other
8 medium and is retrievable in perceivable form.

9 (12) "Sign" means, with present intent to
10 authenticate or adopt a record:

11 (A) to execute or adopt a tangible symbol; or

12 (B) to attach to or logically associate with the
13 record an electronic sound, symbol, or process.

14 (13) "State" means a state of the United States, the
15 District of Columbia, Puerto Rico, the United States Virgin
16 Islands, or any territory or insular possession subject to the
17 jurisdiction of the United States.

18 (14) "Stocks and bonds" means stocks, bonds, mutual
19 funds, and all other types of securities and financial
20 instruments, whether held directly, indirectly, or in any
21 other manner. The term does not include commodity futures
22 contracts and call or put options on stocks or stock indexes.

23 SECTION 26-1A-103. APPLICABILITY. This chapter
24 applies to all powers of attorney, executed on or after
25 January 1, 2012, except:

26 (1) a power to the extent it is coupled with an
27 interest in the subject of the power, including a power given

1 to or for the benefit of a creditor in connection with a
2 credit transaction;

3 (2) a power to make health care decisions;

4 (3) a proxy or other delegation to exercise voting
5 rights or management rights with respect to an entity; and

6 (4) a power created on a form prescribed by a
7 government or governmental subdivision, agency, or
8 instrumentality for a governmental purpose.

9 SECTION 26-1A-104. POWER OF ATTORNEY IS DURABLE. A
10 power of attorney to which this chapter applies is durable,
11 unless it expressly provides that it is terminated by the
12 incapacity of the principal.

13 SECTION 26-1A-105. EXECUTION OF POWER OF ATTORNEY. A
14 power of attorney must be signed by the principal or in the
15 principal's conscious presence by another individual directed
16 by the principal to sign the principal's name on the power of
17 attorney. A signature on a power of attorney is presumed to be
18 genuine if the principal acknowledges the signature before a
19 notary public or other individual authorized by law to take
20 acknowledgments.

21 SECTION 26-1A-106. VALIDITY OF POWER OF ATTORNEY.

22 (a) A power of attorney executed in this state on or
23 after January 1, 2012, is valid if its execution complies with
24 Section 26-1A-105.

25 (b) A power of attorney executed in this state
26 before January 1, 2012, is valid if its execution complied

1 with the law of this state as it existed at the time of
2 execution.

3 (c) A power of attorney executed other than in this
4 state is valid in this state if, when the power of attorney
5 was executed, the execution complied with:

6 (1) the law of the jurisdiction that determines the
7 meaning and effect of the power of attorney pursuant to
8 Section 26-1A-107;

9 (2) the requirements for a military power of
10 attorney pursuant to 10 U.S.C. Section 1044b, as amended; or

11 (3) Alabama law.

12 (d) Except as otherwise provided by statute other
13 than this chapter, a photocopy or electronically transmitted
14 copy of an original power of attorney has the same effect as
15 the original.

16 SECTION 26-1A-107. MEANING AND EFFECT OF POWER OF
17 ATTORNEY. The meaning and effect of a power of attorney is
18 determined by the law of the jurisdiction indicated in the
19 power of attorney and, in the absence of an indication of
20 jurisdiction, by the law of the jurisdiction in which the
21 power of attorney was executed.

22 SECTION 26-1A-108. NOMINATION OF CONSERVATOR OR
23 GUARDIAN; RELATION OF AGENT TO COURT-APPOINTED FIDUCIARY.

24 (a) In a power of attorney, a principal may nominate
25 a conservator of the principal's estate or guardian of the
26 principal's person for consideration by the court, if
27 protective proceedings for the principal's estate or person

1 are begun after the principal executes the power of attorney.
2 Except for good cause shown or disqualification, the court
3 shall make its appointment in accordance with the principal's
4 most recent nomination.

5 (b) If, after a principal executes a power of
6 attorney, a court appoints a conservator of the principal's
7 estate or other fiduciary charged with the management of all
8 the property of the principal or all of his or her property
9 except specified exclusions, the agent is accountable to the
10 fiduciary as well as to the principal. In such event, the
11 fiduciary has the same power to revoke or amend the power of
12 attorney that the principal would have had if he or she was
13 not disabled, incompetent, or incapacitated.

14 SECTION 26-1A-109. WHEN POWER OF ATTORNEY EFFECTIVE.

15 (a) A power of attorney is effective when executed
16 unless the principal provides in the power of attorney that it
17 becomes effective at a future date or upon the occurrence of a
18 future event or contingency.

19 (b) If a power of attorney becomes effective upon
20 the occurrence of a future event or contingency, the
21 principal, in the power of attorney, may authorize one or more
22 persons to determine in a writing or other record that the
23 event or contingency has occurred.

24 (c) If a power of attorney becomes effective upon
25 the principal's incapacity and the principal has not
26 authorized a person to determine whether the principal is
27 incapacitated, or the person authorized is unable or unwilling

1 to make the determination, the power of attorney becomes
2 effective upon a determination in a writing or other record
3 by:

4 (1) a physician or licensed psychologist that the
5 principal is incapacitated within the meaning of Section
6 26-1A-102(5) (A); or

7 (2) an attorney-at-law, a judge, or an appropriate
8 governmental official that the principal is incapacitated
9 within the meaning of Section 26-1A-102(5) (B).

10 (d) A person authorized by the principal in the
11 power of attorney to determine that the principal is
12 incapacitated may act as the principal's personal
13 representative pursuant to the Health Insurance Portability
14 and Accountability Act, Sections 1171 through 1179 of the
15 Social Security Act, 42 U.S.C. Section 1320d, as amended, and
16 applicable regulations, to obtain access to the principal's
17 health care information and communicate with the principal's
18 health care provider.

19 SECTION 26-1A-110. TERMINATION OF POWER OF ATTORNEY
20 OR AGENT'S AUTHORITY.

21 (a) A power of attorney terminates when:

22 (1) the principal dies;

23 (2) the principal becomes incapacitated, if the
24 power of attorney is not durable;

25 (3) the principal revokes the power of attorney;

26 (4) the power of attorney provides that it
27 terminates;

1 (5) the purpose of the power of attorney is
2 accomplished;

3 (6) the principal revokes the agent's authority or
4 the agent dies, becomes incapacitated, or resigns, and the
5 power of attorney does not provide for another agent to act
6 under the power of attorney; or

7 (7) revoked by a fiduciary appointed by a court.

8 (b) An agent's authority terminates when:

9 (1) the principal revokes the authority;

10 (2) the agent dies, becomes incapacitated, or
11 resigns;

12 (3) an action is filed for the divorce or annulment
13 of the agent's marriage to the principal or their legal
14 separation, unless the power of attorney otherwise provides;
15 or

16 (4) the power of attorney terminates.

17 (c) Unless the power of attorney otherwise provides,
18 an agent's authority is exercisable until the authority
19 terminates under subsection (b), notwithstanding a lapse of
20 time since the execution of the power of attorney.

21 (d) Termination of an agent's authority or of a
22 power of attorney is not effective as to the agent that,
23 without actual knowledge of the termination, acts in good
24 faith under the power of attorney. An act so performed, unless
25 otherwise invalid or unenforceable, binds the principal and
26 the principal's successors in interest.

1 (e) Incapacity of the principal of a power of
2 attorney that is not durable does not revoke or terminate the
3 power of attorney as to an agent that, without actual
4 knowledge of the incapacity, acts in good faith under the
5 power of attorney. An act so performed, unless otherwise
6 invalid or unenforceable, binds the principal and the
7 principal's successors in interest.

8 (f) The execution of a power of attorney does not
9 revoke a power of attorney previously executed by the
10 principal unless the subsequent power of attorney provides
11 that the previous power of attorney is revoked or that all
12 other powers of attorney are revoked.

13 SECTION 26-1A-111. CO-AGENTS AND SUCCESSOR AGENTS.

14 (a) A principal may designate two or more persons to
15 act as co-agents. Unless the power of attorney otherwise
16 provides, each co-agent may exercise its authority
17 independently.

18 (b) A principal may designate one or more successor
19 agents to act if an agent resigns, dies, becomes
20 incapacitated, is not qualified to serve, or declines to
21 serve. A principal may grant authority to designate one or
22 more successor agents to an agent or other person designated
23 by name, office, or function. Unless the power of attorney
24 otherwise provides, a successor agent:

25 (1) has the same authority as that granted to the
26 original agent; and

1 (2) may not act until all predecessor agents have
2 resigned, died, become incapacitated, are no longer qualified
3 to serve, or have declined to serve.

4 (c) Except as otherwise provided in the power of
5 attorney and subsection (d), an agent that does not
6 participate in or conceal a breach of fiduciary duty committed
7 by another agent, including a predecessor agent, is not liable
8 for the actions of the other agent.

9 (d) An agent that has accepted appointment and has
10 actual knowledge of a breach or imminent breach of fiduciary
11 duty by another agent shall notify the principal and, if the
12 principal is incapacitated, take any action reasonably
13 appropriate in the circumstances to safeguard the principal's
14 best interest. An agent that fails to notify the principal or
15 take action as required by this subsection is liable for the
16 reasonably foreseeable damages that could have been avoided if
17 the agent had notified the principal or taken such action.

18 SECTION 26-1A-112. REIMBURSEMENT AND COMPENSATION OF
19 AGENT. Unless the power of attorney otherwise provides, an
20 agent is entitled to reimbursement of expenses reasonably
21 incurred on behalf of the principal and to compensation that
22 is reasonable under the circumstances.

23 SECTION 26-1A-113. AGENT'S ACCEPTANCE. Except as
24 otherwise provided in the power of attorney, a person accepts
25 appointment as an agent under a power of attorney by
26 exercising authority or performing duties as an agent or by
27 any other assertion or conduct indicating acceptance.

1 SECTION 26-1A-114. AGENT'S DUTIES.

2 (a) Notwithstanding provisions in the power of
3 attorney, an agent that has accepted appointment shall:

4 (1) act in accordance with the principal's
5 reasonable expectations to the extent actually known by the
6 agent and, otherwise, in the principal's best interest;

7 (2) act in good faith; and

8 (3) act only within the scope of authority granted
9 in the power of attorney.

10 (b) Except as otherwise provided in the power of
11 attorney, an agent that has accepted appointment shall:

12 (1) act loyally for the principal's benefit;

13 (2) act so as not to create a conflict of interest
14 that impairs the agent's ability to act impartially in the
15 principal's best interest;

16 (3) act with the care, competence, and diligence
17 ordinarily exercised by agents in similar circumstances;

18 (4) keep a record of all receipts, disbursements,
19 and transactions made on behalf of the principal;

20 (5) cooperate with a person that has authority to
21 make health care decisions for the principal to carry out the
22 principal's reasonable expectations to the extent actually
23 known by the agent and, otherwise, act in the principal's best
24 interest; and

25 (6) attempt to preserve the principal's estate plan,
26 to the extent actually known by the agent, if preserving the

1 plan is consistent with the principal's best interest based on
2 all relevant factors, including:

3 (A) the value and nature of the principal's
4 property;

5 (B) the principal's foreseeable obligations and need
6 for maintenance;

7 (C) minimization of taxes, including income, estate,
8 inheritance, generation-skipping transfer, and gift taxes; and

9 (D) eligibility for a benefit, a program, or
10 assistance under a statute or regulation.

11 (c) An agent that acts in good faith is not liable
12 to any beneficiary of the principal's estate plan for failure
13 to preserve the plan.

14 (d) An agent that acts with care, competence, and
15 diligence for the best interest of the principal is not liable
16 solely because the agent also benefits from the act or has an
17 individual or conflicting interest in relation to the property
18 or affairs of the principal.

19 (e) If an agent is selected by the principal because
20 of special skills or expertise possessed by the agent or in
21 reliance on the agent's representation that the agent has
22 special skills or expertise, the special skills or expertise
23 must be considered in determining whether the agent has acted
24 with care, competence, and diligence under the circumstances.

25 (f) Absent a breach of duty to the principal, an
26 agent is not liable if the value of the principal's property
27 declines.

1 (g) An agent that exercises authority to delegate to
2 another person the authority granted by the principal or that
3 engages another person on behalf of the principal is not
4 liable for an act, error of judgment, or default of that
5 person if the agent exercises care, competence, and diligence
6 in selecting and monitoring the person.

7 (h) Except as otherwise provided in the power of
8 attorney, an agent is not required to disclose receipts,
9 disbursements, or transactions conducted on behalf of the
10 principal unless ordered by a court or requested by the
11 principal, a guardian, a conservator, another fiduciary acting
12 for the principal, a governmental agency having authority to
13 protect the welfare of the principal, or, upon the death of
14 the principal, by the personal representative or successor in
15 interest of the principal's estate. If so requested, within 30
16 days the agent shall comply with the request or provide a
17 writing or other record substantiating why additional time is
18 needed and shall comply with the request within an additional
19 30 days.

20 SECTION 26-1A-115. EXONERATION OF AGENT. A provision
21 in a power of attorney relieving an agent of liability for
22 breach of duty is binding on the principal and the principal's
23 successors in interest except to the extent the provision:

24 (1) relieves the agent of liability for breach of
25 duty committed dishonestly, with an improper motive, or with
26 reckless indifference to the purposes of the power of attorney
27 or the best interest of the principal; or

1 (2) was inserted as a result of an abuse of a
2 confidential or fiduciary relationship with the principal.

3 SECTION 26-1A-116. JUDICIAL RELIEF.

4 (a) The following persons may petition a court to
5 construe a power of attorney, determine the validity of a
6 power of attorney, or review the agent's conduct, and grant
7 appropriate relief:

8 (1) the principal or the agent;

9 (2) a guardian, conservator, or other fiduciary
10 acting for the principal;

11 (3) a person authorized to make health care
12 decisions for the principal;

13 (4) the principal's spouse, parent, or descendant;

14 (5) an individual who would qualify as a presumptive
15 heir of the principal;

16 (6) a person named as a beneficiary to receive any
17 property, benefit, or contractual right on the principal's
18 death or as a beneficiary of a trust created by or for the
19 principal that has a financial interest in the principal's
20 estate;

21 (7) a governmental agency having regulatory
22 authority to protect the welfare of the principal;

23 (8) the principal's caregiver or another person that
24 demonstrates sufficient interest in the principal's welfare;

25 (9) a person asked to accept the power of attorney;

26 and

1 (10) any other person who demonstrates a sufficient
2 legal interest in the construction or validity of the power of
3 attorney or the agent's conduct in connection with the power
4 of attorney, such as to give that person standing.

5 (b) Upon motion by the principal, the court shall
6 dismiss a petition filed under this section, unless the court
7 finds that the principal lacks capacity to revoke the agent's
8 authority or the power of attorney.

9 SECTION 26-1A-117. AGENT'S LIABILITY TO THE
10 PRINCIPAL. An agent that violates this chapter is liable to
11 the principal or the principal's successors in interest for
12 the amount required to:

13 (1) restore the value of the principal's property to
14 what it would have been had the violation not occurred; and

15 (2) reimburse the principal or the principal's
16 successors in interest for the attorney's fees and costs paid
17 on the agent's behalf.

18 SECTION 26-1A-118. AGENT'S RESIGNATION; NOTICE.
19 Unless the power of attorney provides a different method for
20 an agent's resignation, an agent may resign by giving notice
21 to the principal and, if the principal is incapacitated:

22 (1) to the conservator, or guardian if there is no
23 conservator, if either has been appointed for the principal
24 and a co-agent or successor agent; or

25 (2) if there is no person described in paragraph
26 (1):

27 (A) the principal's caregiver;

1 (B) another person reasonably believed by the agent
2 to have sufficient interest in the principal's welfare; or

3 (C) a governmental agency having authority to
4 protect the welfare of the principal.

5 SECTION 26-1A-119. ACCEPTANCE OF AND RELIANCE UPON
6 ACKNOWLEDGED POWER OF ATTORNEY.

7 (a) For purposes of this section and Section
8 26-1A-120, "acknowledged" means purportedly verified before a
9 notary public or other individual authorized to take
10 acknowledgments and "reasonable time" shall not be deemed to
11 be less than seven business days.

12 (b) A person that effects a transaction in reliance
13 upon an acknowledged power of attorney without actual
14 knowledge that the signature is not genuine may rely upon the
15 presumption under Section 26-1A-105 that the signature is
16 genuine.

17 (c) A person that effects a transaction in reliance
18 upon an acknowledged power of attorney without actual
19 knowledge that the power of attorney is void, invalid, or
20 terminated, that the purported agent's authority is void,
21 invalid, or terminated, or that the agent is exceeding or
22 improperly exercising the agent's authority is fully
23 exonerated from any liability for effecting the transaction in
24 reliance upon the power of attorney as if the power of
25 attorney were genuine, valid, and still in effect, the agent's
26 authority were genuine, valid, and still in effect, and the

1 agent had not exceeded and had properly exercised the
2 authority.

3 (d) A person that is asked to effect a transaction
4 in reliance upon an acknowledged power of attorney may, but is
5 not required to, request, and rely upon, without further
6 investigation:

7 (1) an agent's certification under penalty of
8 perjury of any factual matter concerning the principal, agent,
9 or power of attorney;

10 (2) an acknowledged or properly authenticated
11 English translation of the power of attorney if the power of
12 attorney contains, in whole or in part, language other than
13 English; and

14 (3) an opinion of counsel as to any matter of law
15 concerning the power of attorney if the person making the
16 request provides in a writing or other record the reason for
17 the request.

18 (e) An English translation or an opinion of counsel
19 requested under this section must be provided at the
20 principal's expense if the request is made within a reasonable
21 time after a person is requested to effect a transaction in
22 reliance upon the power of attorney.

23 (f) For purposes of this section and Section
24 26-1A-120, a person that conducts activities through employees
25 is without actual knowledge of a fact relating to a power of
26 attorney, a principal, or an agent if the employee effecting

1 the transaction in reliance upon the power of attorney is
2 without actual knowledge of the fact.

3 SECTION 26-1A-120. LIABILITY FOR REFUSAL TO ACCEPT
4 ACKNOWLEDGED POWER OF ATTORNEY.

5 (a) Except as otherwise provided in subsection (b):

6 (1) a person shall either effect a requested
7 transaction in reliance upon an acknowledged power of attorney
8 or request a certification, a translation, or an opinion of
9 counsel under Section 26-1A-119(d) within a reasonable time
10 after presentation of the power of attorney and a request to
11 effect the transaction;

12 (2) if a person requests a certification, a
13 translation, or an opinion of counsel under Section
14 26-1A-119(d), the person shall effect the transaction in
15 reliance upon the power of attorney within a reasonable time
16 after receipt of the certification, translation, or opinion of
17 counsel; and

18 (3) a person may not require an additional or
19 different form of power of attorney for authority granted in
20 the power of attorney presented.

21 (b) A person is not required to effect a transaction
22 in reliance upon an acknowledged power of attorney:

23 (1) if the person would not be required to engage in
24 the transaction with the principal if the principal was
25 competent and acting on his or her own behalf;

26 (2) if the person reasonably believes engaging in
27 the transaction with the agent or the principal in the same

1 circumstances would be inconsistent with law or any rule or
2 regulation of any government or any governmental agency or
3 instrumentality;

4 (3) if the person has actual knowledge of the fact
5 that the power of attorney is void, invalid, or terminated,
6 that the agent's authority is void, invalid, or terminated, or
7 that the agent is exceeding or improperly exercising the
8 agent's authority;

9 (4) until after a certification, a translation, or
10 an opinion of counsel requested under Section 26-1A-119(d) is
11 provided to such person;

12 (5) if the person in good faith believes that the
13 power of attorney is void, invalid, or terminated, that the
14 agent's authority is void, invalid, or terminated, or that the
15 agent is exceeding or improperly exercising the agent's
16 authority, whether or not a certification, a translation, or
17 an opinion of counsel under Section 26-1A-119(d) has been
18 requested or provided; or

19 (6) if the person makes, or has actual knowledge
20 that another person has made, a report to the Department of
21 Human Resources stating a belief that the principal may be
22 subject to physical or financial abuse, neglect, exploitation,
23 or abandonment by the agent or a person acting for or with the
24 agent.

25 (c) A person that refuses in violation of this
26 section to effect a transaction in reliance upon an
27 acknowledged power of attorney is subject to:

1 (1) a court order mandating that the person effect
2 such transaction in reliance upon the power of attorney; and

3 (2) liability for reasonable attorney's fees and
4 costs incurred in any action or proceeding that confirms the
5 validity of the power of attorney or mandates that the person
6 effect such transaction in reliance upon the power of
7 attorney.

8 SECTION 26-1A-121. PRINCIPLES OF LAW AND EQUITY.

9 Unless displaced by a provision of this chapter, the
10 principles of law and equity supplement this chapter.

11 SECTION 26-1A-122. LAWS APPLICABLE TO FINANCIAL
12 INSTITUTIONS AND ENTITIES. This chapter does not supersede any
13 other law applicable to financial institutions or other
14 entities, and the other law controls if inconsistent with this
15 chapter.

16 SECTION 26-1A-123. REMEDIES UNDER OTHER LAW. The
17 remedies under this chapter are not exclusive and do not
18 abrogate any right or remedy under the law of this state other
19 than this chapter.

20 ARTICLE 2. AUTHORITY

21 SECTION 26-1A-201. AUTHORITY THAT REQUIRES SPECIFIC
22 GRANT; GRANT OF GENERAL AUTHORITY.

23 (a) An agent under a power of attorney may do the
24 following on behalf of the principal or with the principal's
25 property only if the power of attorney expressly grants the
26 agent the authority and exercise of the authority is not

1 otherwise prohibited by another agreement or instrument to
2 which the authority or property is subject:

3 (1) create, amend, revoke, or terminate an inter
4 vivos trust;

5 (2) [reserved];

6 (3) create or change rights of survivorship;

7 (4) create or change a beneficiary designation;

8 (5) delegate authority granted under the power of
9 attorney;

10 (6) waive the principal's right to be a beneficiary
11 of a joint and survivor annuity, including a survivor benefit
12 under a retirement plan; or

13 (7) exercise fiduciary powers that the principal has
14 authority to delegate.

15 (b) Notwithstanding a grant of authority to do an
16 act described in subsection (a), unless the power of attorney
17 otherwise expressly provides, an agent that is not an
18 ancestor, spouse, or descendant of the principal, may not
19 exercise authority under a power of attorney to create in the
20 agent, or in an individual to whom the agent owes a legal
21 obligation of support, an interest in the principal's
22 property, whether by gift, right of survivorship, beneficiary
23 designation, disclaimer, or otherwise.

24 (c) Subject to subsections (a), (b), (d), and (e),
25 if a power of attorney grants to an agent authority to do all
26 acts that a principal could do, the agent has the general
27 authority described in Sections 26-1A-204 through 26-1A-217.

1 (d) Unless the power of attorney otherwise expressly
2 provides, a grant of authority to make a gift is subject to
3 Section 26-1A-217.

4 (e) Subject to subsections (a), (b), and (d), if the
5 subjects over which authority is granted in a power of
6 attorney are similar or overlap, the broadest authority
7 controls.

8 (f) Authority granted in a power of attorney is
9 exercisable with respect to property that the principal has
10 when the power of attorney is executed or acquires later,
11 whether or not the property is located in this state and
12 whether or not the authority is exercised or the power of
13 attorney is executed in this state.

14 (g) An act performed by an agent pursuant to a power
15 of attorney has the same effect and inures to the benefit of
16 and binds the principal and the principal's successors in
17 interest as if the principal had performed the act.

18 SECTION 26-1A-202. INCORPORATION OF AUTHORITY.

19 (a) An agent has authority described in this article
20 if the power of attorney refers to general authority with
21 respect to the descriptive term for the subjects stated in
22 Sections 26-1A-204 through 26-1A-217 or cites the section in
23 which the authority is described.

24 (b) A reference in a power of attorney to general
25 authority with respect to the descriptive term for a subject
26 in Sections 26-1A-204 through 26-1A-217 or a citation to a
27 section of Sections 26-1A-204 through 26-1A-217 incorporates

1 the entire section as if it were set out in full in the power
2 of attorney.

3 (c) A principal may modify authority incorporated by
4 reference.

5 SECTION 26-1A-203. CONSTRUCTION OF AUTHORITY

6 GENERALLY. Except as otherwise provided in the power of
7 attorney, by executing a power of attorney that incorporates
8 by reference a subject described in Sections 26-1A-204 through
9 26-1A-217 or that grants to an agent authority to do all acts
10 that a principal could do pursuant to Section 26-1A-201(c), a
11 principal authorizes the agent, with respect to that subject,
12 to:

13 (1) demand, receive, and obtain by litigation or
14 otherwise, money or another thing of value to which the
15 principal is, may become, or claims to be entitled, and
16 conserve, invest, disburse, or use anything so received or
17 obtained for the purposes intended;

18 (2) contract in any manner with any person, on terms
19 agreeable to the agent, to accomplish a purpose of a
20 transaction and perform, rescind, cancel, terminate, reform,
21 restate, release, or modify the contract or another contract
22 made by or on behalf of the principal;

23 (3) execute, acknowledge, seal, deliver, file, or
24 record any instrument or communication the agent considers
25 desirable to accomplish a purpose of a transaction, including
26 creating at any time a schedule listing some or all of the

1 principal's property and attaching it to the power of
2 attorney;

3 (4) initiate, participate in, submit to alternative
4 dispute resolution, settle, oppose, or propose or accept a
5 compromise with respect to a claim existing in favor of or
6 against the principal or intervene in litigation relating to
7 the claim;

8 (5) seek on the principal's behalf the assistance of
9 a court or other governmental agency to carry out an act
10 authorized in the power of attorney;

11 (6) engage, compensate, and discharge an attorney,
12 accountant, discretionary investment manager, expert witness,
13 or other advisor;

14 (7) prepare, execute, and file a record, report, or
15 other document to safeguard or promote the principal's
16 interest under a statute or regulation;

17 (8) communicate with any representative or employee
18 of a government or governmental subdivision, agency, or
19 instrumentality, on behalf of the principal;

20 (9) access communications intended for, and
21 communicate on behalf of the principal, whether by mail,
22 electronic transmission, telephone, or other means; and

23 (10) do any lawful act with respect to the subject
24 and all property related to the subject.

25 SECTION 26-1A-204. REAL PROPERTY. Unless the power
26 of attorney otherwise provides, language in a power of

1 attorney granting general authority with respect to real
2 property authorizes the agent to:

3 (1) demand, buy, lease, receive, accept as a gift or
4 as security for an extension of credit, or otherwise acquire
5 or reject an interest in real property or a right incident to
6 real property;

7 (2) sell; exchange; convey with or without
8 covenants, representations, or warranties; quitclaim; release;
9 surrender; retain title for security; encumber; partition;
10 consent to partitioning; subject to an easement or covenant;
11 subdivide; apply for zoning or other governmental permits;
12 plat or consent to platting; develop; grant an option
13 concerning; lease; sublease; contribute to an entity in
14 exchange for an interest in that entity; or otherwise grant or
15 dispose of an interest in real property or a right incident to
16 real property;

17 (3) pledge or mortgage an interest in real property
18 or right incident to real property as security to borrow money
19 or pay, renew, or extend the time of payment of a debt of the
20 principal or a debt guaranteed by the principal;

21 (4) release, assign, satisfy, or enforce by
22 litigation or otherwise a mortgage, deed of trust, conditional
23 sale contract, encumbrance, lien, or other claim to real
24 property which exists or is asserted;

25 (5) manage or conserve an interest in real property
26 or a right incident to real property owned or claimed to be
27 owned by the principal, including:

1 (A) insuring against liability or casualty or other
2 loss;

3 (B) obtaining or regaining possession of or
4 protecting the interest or right by litigation or otherwise;

5 (C) paying, assessing, compromising, or contesting
6 taxes or assessments or applying for and receiving refunds in
7 connection with them; and

8 (D) purchasing supplies, hiring assistance or labor,
9 and making repairs or alterations to the real property;

10 (6) use, develop, alter, replace, remove, erect, or
11 install structures or other improvements upon real property in
12 or incident to which the principal has, or claims to have, an
13 interest or right;

14 (7) participate in a reorganization with respect to
15 real property or an entity that owns an interest in or right
16 incident to real property and receive, and hold, and act with
17 respect to stocks and bonds or other property received in a
18 plan of reorganization, including:

19 (A) selling or otherwise disposing of them;

20 (B) exercising or selling an option, right of
21 conversion, or similar right with respect to them; and

22 (C) exercising any voting rights in person or by
23 proxy;

24 (8) change the form of title of an interest in or
25 right incident to real property; and

1 (9) dedicate to public use, with or without
2 consideration, easements or other real property in which the
3 principal has, or claims to have, an interest.

4 SECTION 26-1A-205. TANGIBLE PERSONAL PROPERTY.

5 Unless the power of attorney otherwise provides, language in a
6 power of attorney granting general authority with respect to
7 tangible personal property authorizes the agent to:

8 (1) demand, buy, receive, accept as a gift or as
9 security for an extension of credit, or otherwise acquire or
10 reject ownership or possession of tangible personal property
11 or an interest in tangible personal property;

12 (2) sell; exchange; convey with or without
13 covenants, representations, or warranties; quitclaim; release;
14 surrender; create a security interest in; grant options
15 concerning; lease; sublease; or, otherwise dispose of tangible
16 personal property or an interest in tangible personal
17 property;

18 (3) grant a security interest in tangible personal
19 property or an interest in tangible personal property as
20 security to borrow money or pay, renew, or extend the time of
21 payment of a debt of the principal or a debt guaranteed by the
22 principal;

23 (4) release, assign, satisfy, or enforce by
24 litigation or otherwise, a security interest, lien, or other
25 claim on behalf of the principal, with respect to tangible
26 personal property or an interest in tangible personal
27 property;

1 (5) manage or conserve tangible personal property or
2 an interest in tangible personal property on behalf of the
3 principal, including:

4 (A) insuring against liability or casualty or other
5 loss;

6 (B) obtaining or regaining possession of or
7 protecting the property or interest, by litigation or
8 otherwise;

9 (C) paying, assessing, compromising, or contesting
10 taxes or assessments or applying for and receiving refunds in
11 connection with taxes or assessments;

12 (D) moving the property from place to place;

13 (E) storing the property for hire or on a gratuitous
14 bailment; and

15 (F) using and making repairs, alterations, or
16 improvements to the property; and

17 (6) change the form of title of an interest in
18 tangible personal property.

19 SECTION 26-1A-206. STOCKS AND BONDS. Unless the
20 power of attorney otherwise provides, language in a power of
21 attorney granting general authority with respect to stocks and
22 bonds authorizes the agent to:

23 (1) buy, sell, and exchange stocks and bonds;

24 (2) establish, continue, modify, or terminate an
25 account with respect to stocks and bonds;

1 (3) pledge stocks and bonds as security to borrow,
2 pay, renew, or extend the time of payment of a debt of the
3 principal;

4 (4) receive certificates and other evidences of
5 ownership with respect to stocks and bonds; and

6 (5) exercise voting rights with respect to stocks
7 and bonds in person or by proxy, enter into voting trusts, and
8 consent to limitations on the right to vote.

9 SECTION 26-1A-207. COMMODITIES AND OPTIONS. Unless
10 the power of attorney otherwise provides, language in a power
11 of attorney granting general authority with respect to
12 commodities and options authorizes the agent to:

13 (1) buy, sell, exchange, assign, settle, and
14 exercise commodity futures contracts and call or put options
15 on stocks or stock indexes traded on a regulated option
16 exchange; and

17 (2) establish, continue, modify, and terminate
18 option accounts.

19 SECTION 26-1A-208. BANKS AND OTHER FINANCIAL
20 INSTITUTIONS. Unless the power of attorney otherwise provides,
21 language in a power of attorney granting general authority
22 with respect to banks and other financial institutions
23 authorizes the agent to:

24 (1) continue, modify, and terminate an account or
25 other banking arrangement made by or on behalf of the
26 principal;

1 (2) establish, modify, and terminate an account or
2 other banking arrangement with a bank, trust company, savings
3 and loan association, credit union, thrift company, brokerage
4 firm, or other financial institution selected by the agent;

5 (3) contract for services available from a financial
6 institution, including renting a safe deposit box or space in
7 a vault;

8 (4) withdraw, by check, order, electronic funds
9 transfer, or otherwise, money or property of the principal
10 deposited with or left in the custody of a financial
11 institution;

12 (5) receive statements of account, vouchers,
13 notices, and similar documents from a financial institution
14 and act with respect to them;

15 (6) enter a safe deposit box or vault and withdraw
16 or add to the contents;

17 (7) borrow money and pledge as security personal
18 property of the principal necessary to borrow money or pay,
19 renew, or extend the time of payment of a debt of the
20 principal or a debt guaranteed by the principal;

21 (8) make, assign, draw, endorse, discount,
22 guarantee, and negotiate promissory notes, checks, drafts, and
23 other negotiable or nonnegotiable paper of the principal or
24 payable to the principal or the principal's order, transfer
25 money, receive the cash or other proceeds of those
26 transactions, and accept a draft drawn by a person upon the
27 principal and pay it when due;

1 (9) receive for the principal and act upon a sight
2 draft, warehouse receipt, or other document of title whether
3 tangible or electronic, or other negotiable or nonnegotiable
4 instrument;

5 (10) apply for, receive, and use letters of credit,
6 credit and debit cards, electronic transaction authorizations,
7 and traveler's checks from a financial institution and give an
8 indemnity or other agreement in connection with letters of
9 credit; and

10 (11) consent to an extension of the time of payment
11 with respect to commercial paper or a financial transaction
12 with a financial institution.

13 SECTION 26-1A-209. OPERATION OF ENTITY OR BUSINESS.

14 Subject to the terms of a document or an agreement governing
15 an entity or an entity ownership interest, and unless the
16 power of attorney otherwise provides, language in a power of
17 attorney granting general authority with respect to operation
18 of an entity or business authorizes the agent to:

19 (1) operate, buy, sell, enlarge, reduce, or
20 terminate an ownership interest;

21 (2) perform a duty or discharge a liability and
22 exercise in person or by proxy a right, power, privilege, or
23 option that the principal has, may have, or claims to have;

24 (3) enforce the terms of an ownership agreement;

25 (4) initiate, participate in, submit to alternative
26 dispute resolution, settle, oppose, or propose or accept a

1 compromise with respect to litigation to which the principal
2 is a party because of an ownership interest;

3 (5) exercise in person or by proxy, or enforce by
4 litigation or otherwise, a right, power, privilege, or option
5 the principal has or claims to have as the holder of stocks
6 and bonds;

7 (6) initiate, participate in, submit to alternative
8 dispute resolution, settle, oppose, or propose or accept a
9 compromise with respect to litigation to which the principal
10 is a party concerning stocks and bonds;

11 (7) with respect to an entity or business owned
12 solely by the principal:

13 (A) continue, modify, renegotiate, extend, and
14 terminate a contract made by or on behalf of the principal
15 with respect to the entity or business before execution of the
16 power of attorney;

17 (B) determine:

18 (i) the location of its operation;

19 (ii) the nature and extent of its business;

20 (iii) the methods of manufacturing, selling,
21 merchandising, financing, accounting, and advertising employed
22 in its operation;

23 (iv) the amount and types of insurance carried; and

24 (v) the mode of engaging, compensating, and dealing
25 with its employees and accountants, attorneys, or other
26 advisors;

1 (C) change the name or form of organization under
2 which the entity or business is operated and enter into an
3 ownership agreement with other persons to take over all or
4 part of the operation of the entity or business; and

5 (D) demand and receive money due or claimed by the
6 principal or on the principal's behalf in the operation of the
7 entity or business and control and disburse the money in the
8 operation of the entity or business;

9 (8) put additional capital into an entity or
10 business in which the principal has an interest;

11 (9) join in a plan of reorganization, consolidation,
12 conversion, domestication, or merger of the entity or
13 business;

14 (10) sell or liquidate all or part of an entity or
15 business;

16 (11) establish the value of an entity or business
17 under a buy-out agreement to which the principal is a party;

18 (12) prepare, sign, file, and deliver reports,
19 compilations of information, returns, or other papers with
20 respect to an entity or business and make related payments;
21 and

22 (13) pay, compromise, or contest taxes, assessments,
23 fines, or penalties and perform any other act to protect the
24 principal from illegal or unnecessary taxation, assessments,
25 fines, or penalties, with respect to an entity or business,
26 including attempts to recover, in any manner permitted by law,

1 money paid before or after the execution of the power of
2 attorney.

3 SECTION 26-1A-210. INSURANCE AND ANNUITIES. Unless
4 the power of attorney otherwise provides, language in a power
5 of attorney granting general authority with respect to
6 insurance and annuities authorizes the agent to:

7 (1) continue, pay the premium or make a contribution
8 on, modify, exchange, rescind, release, or terminate a
9 contract procured by or on behalf of the principal which
10 insures or provides an annuity to either the principal or
11 another person, whether or not the principal is a beneficiary
12 under the contract;

13 (2) procure new, different, and additional contracts
14 of insurance and annuities for the principal and the
15 principal's spouse, children, and other dependents, and select
16 the amount, type of insurance or annuity, and mode of payment;

17 (3) pay the premium or make a contribution on,
18 modify, exchange, rescind, release, or terminate a contract of
19 insurance or annuity procured by the agent;

20 (4) apply for and receive a loan secured by a
21 contract of insurance or annuity;

22 (5) surrender and receive the cash surrender value
23 on a contract of insurance or annuity;

24 (6) exercise an election;

25 (7) exercise investment powers available under a
26 contract of insurance or annuity;

1 (8) change the manner of paying premiums on a
2 contract of insurance or annuity;

3 (9) change or convert the type of insurance or
4 annuity with respect to which the principal has or claims to
5 have authority described in this section;

6 (10) apply for and procure a benefit or assistance
7 under a statute or regulation to guarantee or pay premiums of
8 a contract of insurance on the life of the principal;

9 (11) collect, sell, assign, hypothecate, borrow
10 against, or pledge the interest of the principal in a contract
11 of insurance or annuity;

12 (12) select the form and timing of the payment of
13 proceeds from a contract of insurance or annuity; and

14 (13) pay, from proceeds or otherwise, compromise or
15 contest, and apply for refunds in connection with, a tax or
16 assessment levied by a taxing authority with respect to a
17 contract of insurance or annuity or its proceeds or liability
18 accruing by reason of the tax or assessment.

19 SECTION 26-1A-211. ESTATES, TRUSTS, AND OTHER
20 BENEFICIAL INTERESTS.

21 (a) In this section, "estates, trusts, and other
22 beneficial interests" means a trust, probate estate,
23 guardianship, conservatorship, escrow, or custodianship or a
24 fund from which the principal is, may become, or claims to be,
25 entitled to a share or payment.

26 (b) Unless the power of attorney otherwise provides,
27 language in a power of attorney granting general authority

1 with respect to estates, trusts, and other beneficial
2 interests authorizes the agent to:

3 (1) accept, receive, receipt for, sell, assign,
4 pledge, or exchange a share in or payment from the fund;

5 (2) demand or obtain money or another thing of value
6 to which the principal is, may become, or claims to be,
7 entitled by reason of the fund, by litigation or otherwise;

8 (3) exercise for the benefit of the principal a
9 presently exercisable general power of appointment held by the
10 principal;

11 (4) initiate, participate in, submit to alternative
12 dispute resolution, settle, oppose, or propose or accept a
13 compromise with respect to litigation to ascertain the
14 meaning, validity, or effect of a deed, will, declaration of
15 trust, or other instrument or transaction affecting the
16 interest of the principal;

17 (5) initiate, participate in, submit to alternative
18 dispute resolution, settle, oppose, or propose or accept a
19 compromise with respect to litigation to remove, substitute,
20 or surcharge a fiduciary;

21 (6) conserve, invest, disburse, or use anything
22 received for an authorized purpose;

23 (7) transfer an interest of the principal in real
24 property, stocks and bonds, accounts with financial
25 institutions or securities intermediaries, insurance,
26 annuities, and other property to the trustee of a revocable
27 trust created by the principal as settlor; and

1 (8) reject, renounce, disclaim, release, or consent
2 to a reduction in or modification of a share in or payment
3 from the fund.

4 SECTION 26-1A-212. CLAIMS AND LITIGATION. Unless the
5 power of attorney otherwise provides, language in a power of
6 attorney granting general authority with respect to claims and
7 litigation authorizes the agent to:

8 (1) assert and maintain before a court or
9 administrative agency a claim, claim for relief, cause of
10 action, counterclaim, offset, recoupment, or defense,
11 including an action to recover property or other thing of
12 value, recover damages sustained by the principal, eliminate
13 or modify tax liability, or seek an injunction, specific
14 performance, or other relief;

15 (2) bring an action to determine adverse claims or
16 intervene or otherwise participate in litigation;

17 (3) seek an attachment, garnishment, order of
18 arrest, or other preliminary, provisional, or intermediate
19 relief and use an available procedure to effect or satisfy a
20 judgment, order, or decree;

21 (4) make or accept a tender, offer of judgment, or
22 admission of facts, submit a controversy on an agreed
23 statement of facts, consent to examination, and bind the
24 principal in litigation;

25 (5) submit to alternative dispute resolution,
26 settle, and propose or accept a compromise;

1 (6) waive the issuance and service of process upon
2 the principal, accept service of process, appear for the
3 principal, designate persons upon which process directed to
4 the principal may be served, execute and file or deliver
5 stipulations on the principal's behalf, verify pleadings, seek
6 appellate review, procure and give surety and indemnity bonds,
7 contract and pay for the preparation and printing of records
8 and briefs, receive, execute, and file or deliver a consent,
9 waiver, release, confession of judgment, satisfaction of
10 judgment, notice, agreement, or other instrument in connection
11 with the prosecution, settlement, or defense of a claim or
12 litigation;

13 (7) act for the principal with respect to bankruptcy
14 or insolvency, whether voluntary or involuntary, concerning
15 the principal or some other person, or with respect to a
16 reorganization, receivership, or application for the
17 appointment of a receiver or trustee which affects an interest
18 of the principal in property or other thing of value;

19 (8) pay a judgment, award, or order against the
20 principal or a settlement made in connection with a claim or
21 litigation; and

22 (9) receive money or other thing of value paid in
23 settlement of or as proceeds of a claim or litigation.

24 SECTION 26-1A-213. PERSONAL AND FAMILY MAINTENANCE.

25 (a) Unless the power of attorney otherwise provides,
26 language in a power of attorney granting general authority

1 with respect to personal and family maintenance authorizes the
2 agent to:

3 (1) perform the acts necessary to maintain the
4 customary standard of living of the principal, the principal's
5 spouse, and the following individuals, whether living when the
6 power of attorney is executed or later born:

7 (A) the principal's children;

8 (B) other individuals legally entitled to be
9 supported by the principal; and

10 (C) the individuals whom the principal has
11 customarily supported or indicated the intent to support;

12 (2) make periodic payments of child support and
13 other family maintenance required by a court or governmental
14 agency or an agreement to which the principal is a party;

15 (3) provide living quarters for the individuals
16 described in paragraph (1) by:

17 (A) purchase, lease, or other contract; or

18 (B) paying the operating costs, including interest,
19 amortization payments, repairs, improvements, and taxes, for
20 premises owned by the principal or occupied by those
21 individuals;

22 (4) provide normal domestic help, usual vacations
23 and travel expenses, and funds for shelter, clothing, food,
24 appropriate education, including postsecondary and vocational
25 education, and other current living costs for the individuals
26 described in paragraph (1);

1 (5) pay expenses for necessary health care and
2 custodial care on behalf of the individuals described in
3 paragraph (1);

4 (6) act as the principal's personal representative
5 pursuant to the Health Insurance Portability and
6 Accountability Act, Sections 1171 through 1179 of the Social
7 Security Act, 42 U.S.C. Section 1320d, as amended, and
8 applicable regulations, in making decisions related to the

17 (8) maintain credit and debit accounts for the
18 convenience of the individuals described in paragraph (1) and
19 open new accounts; and

20 (9) continue payments incidental to the membership
21 or affiliation of the principal in a religious institution,
22 club, society, order, or other organization or to continue
23 contributions to those organizations.

24 (b) Authority with respect to personal and family
25 maintenance is neither dependent upon, nor limited by,
26 authority that an agent may or may not have with respect to
27 gifts under this chapter.

1 SECTION 26-1A-214. BENEFITS FROM GOVERNMENTAL
2 PROGRAMS OR CIVIL OR MILITARY SERVICE.

3 (a) In this section, "benefits from governmental
4 programs or civil or military service" means any benefit,
5 program, or assistance provided under a statute or regulation
6 including, but not limited to, Social Security, Medicare, and
7 Medicaid.

8 (b) Unless the power of attorney otherwise provides,
9 language in a power of attorney granting general authority
10 with respect to benefits from governmental programs or civil
11 or military service authorizes the agent to:

12 (1) execute vouchers in the name of the principal
13 for allowances and reimbursements payable by the United States
14 or a foreign government or by a state or subdivision of a
15 state to the principal, including allowances and
16 reimbursements for transportation of the individuals described
17 in Section 26-1A-213(a)(1), and for shipment of their
18 household effects;

19 (2) take possession and order the removal and
20 shipment of property of the principal from a post, warehouse,
21 depot, dock, or other place of storage or safekeeping, either
22 governmental or private, and execute and deliver a release,
23 voucher, receipt, bill of lading, shipping ticket,
24 certificate, or other instrument for that purpose;

25 (3) enroll in, apply for, select, reject, change,
26 amend, or discontinue, on the principal's behalf, a benefit or
27 program;

1 (4) prepare, file, and maintain a claim of the
2 principal for a benefit or assistance, financial or otherwise,
3 to which the principal may be entitled under a statute or
4 regulation;

5 (5) initiate, participate in, submit to alternative
6 dispute resolution, settle, oppose, or propose or accept a
7 compromise with respect to litigation concerning any benefit
8 or assistance the principal may be entitled to receive under a
9 statute or regulation; and

10 (6) receive the financial proceeds of a claim
11 described in paragraph (4) and conserve, invest, disburse, or
12 use for a lawful purpose anything so received.

13 SECTION 26-1A-215. RETIREMENT PLANS.

14 (a) In this section, "retirement plan" means a plan
15 or account created by an employer, the principal, or another
16 individual to provide retirement benefits or deferred
17 compensation of which the principal is a participant,
18 beneficiary, or owner, including a plan or account under the
19 following sections of the Internal Revenue Code:

20 (1) an individual retirement account under Internal
21 Revenue Code Section 408, 26 U.S.C. Section 408, as amended;

4 (5) a pension, profit-sharing, stock bonus, or other
5 retirement plan qualified under Internal Revenue Code Section
6 401(a), 26 U.S.C. Section 401(a), as amended;

7 (6) a plan under Internal Revenue Code Section
8 457(b), 26 U.S.C. Section 457(b), as amended; and

9 (7) a non-qualified deferred compensation plan under
10 Internal Revenue Code Section 409A, 26 U.S.C. Section 409A, as
11 amended.

12 (b) Unless the power of attorney otherwise provides,
13 language in a power of attorney granting general authority
14 with respect to retirement plans authorizes the agent to:

15 (1) select the form and timing of payments under a
16 retirement plan and withdraw benefits from a plan;

17 (2) make a rollover, including a direct
18 trustee-to-trustee rollover, of benefits from one retirement
19 plan to another;

20 (3) establish a retirement plan in the principal's
21 name;

22 (4) make contributions to a retirement plan;

23 (5) exercise investment powers available under a
24 retirement plan; and

25 (6) borrow from, sell assets to, or purchase assets
26 from a retirement plan.

1 SECTION 26-1A-216. TAXES. Unless the power of
2 attorney otherwise provides, language in a power of attorney
3 granting general authority with respect to taxes authorizes

17 (2) pay taxes due, collect refunds, post bonds,
18 receive confidential information, and contest deficiencies
19 determined by the Internal Revenue Service or other taxing
20 authority;

21 (3) exercise any election available to the principal
22 under federal, state, local, or foreign tax law; and

23 (4) act for the principal in all tax matters for all
24 periods before the Internal Revenue Service, or other taxing
25 authority.

26 SECTION 26-1A-217. GIFTS.

1 (a) In this section, a gift "for the benefit of" a
2 person includes a gift to a trust, an account under the
3 Uniform Transfers to Minors Act, and a tuition savings account
4 or prepaid tuition plan as defined under Internal Revenue Code
5 Section 529, 26 U.S.C. Section 529, as amended.

6 (b) Unless the power of attorney otherwise expressly
7 provides, language in a power of attorney granting general
8 authority with respect to gifts authorizes the agent only to:

9 (1) make outright to, or for the benefit of, a
10 person including the agent, a gift of any of the principal's
11 property, including by the exercise of a presently exercisable
12 general power of appointment held by the principal, in an
13 amount per donee not to exceed the annual dollar limits of the
14 federal gift tax exclusion under Internal Revenue Code Section
15 2503(b), 26 U.S.C. Section 2503(b), as amended, without regard
16 to whether the federal gift tax exclusion applies to the gift,
17 or if the principal's spouse agrees to consent to a split gift
18 pursuant to Internal Revenue Code Section 2513, 26 U.S.C.
19 2513, as amended, in an amount per donee not to exceed twice
20 the annual federal gift tax exclusion limit; and

20 ARTICLE 4. MISCELLANEOUS PROVISIONS

21 SECTION 26-1A-401. UNIFORMITY OF APPLICATION AND
22 CONSTRUCTION. In applying and construing this uniform act,
23 consideration must be given to the need to promote uniformity
24 of the law with respect to its subject matter among the states
25 that enact it.

26 SECTION 26-1A-402. RELATION TO ELECTRONIC SIGNATURES
27 IN GLOBAL AND NATIONAL COMMERCE ACT. This chapter modifies,

1 limits, and supersedes the federal Electronic Signatures in
2 Global and National Commerce Act, 15 U.S.C. Section 7001 et
3 seq., but does not modify, limit, or supersede Section 101(c)
4 of that act, 15 U.S.C. Section 7001(c), or authorize
5 electronic delivery of any of the notices described in Section
6 103(b) of that act, 15 U.S.C. Section 7003(b).

7 SECTION 26-1A-403. EFFECT ON EXISTING POWERS OF
8 ATTORNEY. This chapter applies to all non-health care powers
9 of attorney executed on or after January 1, 2012.

10 SECTION 26-1A-404. HEALTH CARE POWERS OF ATTORNEY
11 EXECUTED ON OR AFTER JANUARY 1, 2012.

12 (a) This section applies to a power of attorney for
13 health care decisions executed on or after January 1, 2012.

14 (b) A durable power of attorney is a power of
15 attorney by which a principal designates another his or her
16 attorney in fact or agent in writing and the writing contains
17 the words "This power of attorney shall not be affected by
18 disability, incompetency, or incapacity of the principal" or
19 "This power of attorney shall become effective upon the
20 disability, incompetency, or incapacity of the principal" or
21 similar words showing the intent of the principal that the
22 authority conferred shall be exercisable notwithstanding the
23 principal's subsequent disability, incompetency, or
24 incapacity.

25 (c) (1) A principal may designate under a durable
26 power of attorney an individual who shall be empowered to make
27 health care decisions on behalf of the principal, in the

1 manner set forth in the Natural Death Act, if in the opinion
2 of the principal's attending physician the principal is no
3 longer able to give directions to health care providers.
4 Subject to the express limitation on the authority of the
5 attorney in fact contained in the durable power of attorney,
6 the attorney in fact may make any health care decision on
7 behalf of the principal that the principal could make but for
8 the lack of capacity of the principal to make a decision, but
9 not including psychosurgery, sterilization, abortion when not
10 necessary to preserve the life of the principal, or
11 involuntary hospitalization or treatment covered by Subtitle 2
12 of Title 22. A durable power of attorney executed pursuant to
13 this section may be revoked by written revocation signed and
14 dated by the principal or person acting at the direction of
15 the principal, or being obliterated, burnt, torn, or otherwise
16 destroyed or defaced in a manner indicating intention to
17 cancel or by a verbal expression of intent to revoke made in
18 the presence of a witness 19 years of age or older who signs
19 and dates a writing confirming an expression to revoke.

20 (2) Notwithstanding anything in this section to the
21 contrary, an attorney in fact shall have the authority to make
22 decisions regarding provision, withholding, or withdrawal of
23 life-sustaining treatment and artificially provided nutrition
24 and hydration but only a. if specifically authorized to do so
25 in the durable power of attorney, b. if the substantive
26 provisions of the durable power of attorney are in substantial
27 compliance and if the durable power of attorney is executed

1 and accepted in substantially the same form as set forth in
2 the Alabama Natural Death Act, and c. in instances of terminal
3 illness or injury or permanent unconsciousness, if the
4 authority is implemented in the manner permitted under the
5 Alabama Natural Death Act. All durable powers of attorney
6 executed prior to January 1, 2012, shall be effective to the
7 extent specifically provided therein notwithstanding the
8 provisions of this subsection. The decisions made by the
9 attorney in fact shall be implemented in accordance with the
10 same procedures set forth in the Alabama Natural Death Act for
11 health care proxies.

12 (3) Any authority granted to the spouse under a
13 durable power of attorney shall be revoked if the marriage of
14 the principal is dissolved or annulled, or if the parties are
15 legally separated or a party to divorce proceedings.

16 (4) Subject to any limitation in the durable power
17 of attorney, an attorney in fact may, for the purpose of
18 making a health care decision, request, review, and receive
19 any information, oral or written, regarding the principal's
20 physical or mental health, including medical and hospital
21 records, execute a release or other document required to
22 obtain the information, and consent to the disclosure of the
23 information.

24 (5) Under no circumstances shall the health care
25 provider of the principal or a nonrelative employee of the
26 health care provider of the principal make decisions under the
27 durable power of attorney. For purposes of this subsection, a

1 health care provider is defined as any person or entity who is
2 licensed, certified, registered, or otherwise authorized by
3 the laws of this state to administer or provide health care in
4 the ordinary course of business or in the practice of a
5 profession.

6 (6) No health care provider or any employee or agent
7 thereof who in good faith and pursuant to reasonable medical
8 standards follows the direction of a duly authorized attorney
9 in fact shall, as a result thereof, be subject to criminal or
10 civil liability, or be found to have committed an act of
11 unprofessional conduct for an action taken thereunder. Any
12 health care cost or liability for the cost associated with any
13 decision made pursuant to this section shall be the same as if
14 the health care were provided as a result of the principal's
15 decision relating to his or her own care.

16 (7) Any person who, without the consent of the
17 principal, willfully conceals, cancels, or alters a durable
18 power of attorney or any amendment or revocation of the agency

5 civil liability for that action.

6 (9) Nothing in this subsection regarding the
7 appointment of an attorney in fact with respect to health care
8 decisions shall impair or supersede any legal right or legal
9 responsibility which any person may have, under case law,
10 common law, or statutory law to effect the provision,
11 withholding, or withdrawal of life-sustaining treatment or
12 artificially provided nutrition and hydration in any lawful
13 manner. In such respect, the provisions of this subsection are
14 cumulative.

15 (10) No physician or other health care provider, and
16 no health care service plan, health maintenance organization,
17 insurer issuing disability or life or health insurance,
18 self-insured employee welfare benefit plan, nonprofit medical
19 service corporation, or mutual nonprofit hospital or hospital
20 service corporation shall require any person to execute a
21 durable power of attorney with respect to health care
22 decisions as a condition for being insured for, or receiving,
23 health care services.

24 (11) Nothing in this subsection regarding the
25 appointment of an attorney in fact with respect to health care
26 decisions shall impair or supersede the jurisdiction of the
27 circuit court in the county where a patient is undergoing

1 treatment to determine whether life-sustaining treatment or
2 artificially provided nutrition and hydration shall be
3 withheld or withdrawn in circumstances not governed by this
4 subsection.

5 (12) This subsection shall create no presumption
6 concerning the intention of an individual, who has not
7 executed a durable power of attorney regarding health care
8 decisions, or any other advance directive for health care, or
9 if the durable power of attorney, or advance directive for
10 health care is executed, the durable power of attorney or
11 advance directive for health care is ambiguous or silent as to
12 a particular health care matter, to consent to the use or
13 withdrawing or withholding of life-sustaining treatment or
14 artificially provided nutrition and hydration. The terms
15 "person" and "advance directive for health care" shall have
16 the meaning as under Sections 22-8A-1, et seq.

17 (13) A durable power of attorney executed in another
18 state in compliance with the law of that state or of this
19 state is valid for purposes of this subsection, but this
20 subsection does not authorize the administration, withholding,
21 or withdrawal of health care otherwise prohibited by the laws
22 of this state.

23 (14) Any durable power of attorney regarding health
24 care decisions made prior to January 1, 2012, shall be given
25 effect provided that the durable power of attorney was legally
26 effective when written and artificially provided nutrition and

1 hydration shall not be withdrawn pursuant to the durable power
2 of attorney unless specifically authorized herein.

3 Section 2. Section 26-1-2 of the Code of Alabama
4 1975, is amended to read as follows:

5 "§26-1-2.

6 "(a) A durable power of attorney is a power of
7 attorney by which a principal designates another his or her
8 attorney in fact or agent in writing and the writing contains
9 the words "This power of attorney shall not be affected by
10 disability, incompetency, or incapacity of the principal" or
11 "This power of attorney shall become effective upon the

22 principal was competent, not disabled, and not incapacitated.

23 "(c) (1) If, following execution of a durable power
24 of attorney, a court of the domicile of the principal appoints
25 a guardian, curator, or other fiduciary charged with the
26 management of all the property of the principal or all of his
27 or her property except specified exclusions, the attorney in

1 fact is accountable to the fiduciary as well as to the
2 principal. The fiduciary has the same power to revoke or amend
3 the power of attorney that the principal would have had if he
4 or she was not disabled, incompetent, or incapacitated.

5 "(2) A principal may nominate, by a durable power of
6 attorney, the guardian, curator, or other fiduciary for
7 consideration by the court if proceedings to appoint a
8 fiduciary for the principal are thereafter commenced. The

12 "(d) (1) The death of a principal who has executed a
13 written power of attorney, durable or otherwise, does not
14 revoke or terminate the agency as to the attorney in fact or
15 other person who, without actual knowledge of the death of the
16 principal, acts in good faith under the power. Any action so
17 taken, unless otherwise invalid or unenforceable, binds the
18 successors in interest of the principal.

19 "(2) The disability, incompetency, or incapacity of
20 a principal who has previously executed a written power of
21 attorney that is not a durable power does not revoke or
22 terminate the agency as to the attorney in fact or other
23 person who, without actual knowledge of the disability,
24 incompetency, or incapacity of the principal, acts in good
25 faith under the power. Any action so taken, unless otherwise
26 invalid or unenforceable, binds the principal and his or her
27 successors in interest.

1 "(e) As to acts undertaken in good faith reliance
2 thereon, an affidavit executed by the attorney in fact under a
3 power of attorney, durable or otherwise, stating that he or
4 she did not have, at the time of the exercise of the power,
5 actual knowledge of the termination of the power by revocation
6 or of the death, disability, incompetency, or incapacity of
7 the principal is conclusive proof of the nonrevocation or
8 nontermination of the power at that time. If the exercise of
9 the power of attorney requires execution and delivery of any
10 instrument that is recordable, the affidavit, when
11 authenticated for record, is likewise recordable.

12 "(f) This section shall not affect any provision in
13 a power of attorney for its termination by expiration of time
14 or occurrence of an event other than express revocation or a
15 change in the principal's capacity.

16 "(g) (1) A principal may designate under a durable
17 power of attorney an individual who shall be empowered to make
18 health care decisions on behalf of the principal, in the
19 manner set forth in the Natural Death Act, if in the opinion
20 of the principal's attending physician the principal is no
21 longer able to give directions to health care providers.
22 Subject to the express limitation on the authority of the
23 attorney in fact contained in the durable power of attorney,
24 the attorney in fact may make any health care decision on
25 behalf of the principal that the principal could make but for
26 the lack of capacity of the principal to make a decision, but
27 not including psychosurgery, sterilization, abortion when not

5 the principal is dissolved or annulled, or if the parties are
6 legally separated or a party to divorce proceedings.

8 of attorney, an attorney in fact may, for the purpose of
9 making a health care decision, request, review, and receive
10 any information, oral or written, regarding the principal's
11 physical or mental health, including medical and hospital
12 records, execute a release or other document required to
13 obtain the information, and consent to the disclosure of the
14 information.

15 "(5) Under no circumstances shall the health care
16 provider of the principal or a nonrelative employee of the
17 health care provider of the principal make decisions under the
18 durable power of attorney. For purposes of this subsection, a
19 health care provider is defined as any person or entity who is
20 licensed, certified, registered, or otherwise authorized by
21 the laws of this state to administer or provide health care in
22 the ordinary course of business or in the practice of a
23 profession.

24 "(6) No health care provider or any employee or
25 agent thereof who in good faith and pursuant to reasonable
26 medical standards follows the direction of a duly authorized
27 attorney in fact shall, as a result thereof, be subject to

1 criminal or civil liability, or be found to have committed an
2 act of unprofessional conduct for an action taken thereunder.
3 Any health care cost or liability for the cost associated with
4 any decision made pursuant to this section shall be the same
5 as if the health care were provided as a result of the
6 principal's decision relating to his or her own care.

7 "(7) Any person who, without the consent of the
8 principal, willfully conceals, cancels, or alters a durable
