9		and use taxes upon certain persons, firms, or

6	Clubs is exempted from paying or collecting any state, county
7	and municipal sales and use taxes.
8	Section 2. This act shall become effective on the
9	first day of the third month following its passage and
10	approval by the Governor, or its otherwise becoming law.
