Section 1. Section 24-1-28, Code of Alabama 1975, is amended to read as follows:

"\$24-1-28.

"(a) The authority shall have the right to acquire by eminent domain any property, real or personal, which it may deem necessary to carry out the purposes of this article, after the adoption by it of a resolution declaring that the acquisition of the property described therein is in the public interest and necessary for public use. The authority may exercise the power of eminent domain pursuant to the provisions of Title 18. Property already devoted to a public use may be acquired; provided, that no property belonging to any city within the boundaries of the authority, or to any government, may be acquired without its consent, and that no property belonging to a public utility corporation may be acquired without the approval of the Public Service Commission or other body having regulatory power over such corporation.

"(b) In Class 3 municipalities, except a Class 3
municipality organized under Act 618 of the 1973 Regular

Session, the authority may purchase real property only after
notice of intent to purchase the property is given to
surrounding property owners. Notice of the proposed purchase
in such Class 3 municipalities shall be sent via first class
mail to each residential and business address within 500 yards
of the property proposed to be purchased not less than 30 days
