1 2 ENROLLED, House Joint Resolution, 3 COMMENDING HUNTSVILLE POLICE OFFICER GRADY THIGPEN AS A NOMINEE FOR THE 2011 ALABAMA LEGISLATIVE MEDAL OF HONOR 4 5 FOR LAW ENFORCEMENT. 6 7 WHEREAS, it is with highest commendation that we 8 recognize Huntsville Police Officer Grady Thigpen as a nominee for the 2011 Alabama Legislative Medal of Honor for Law 9 10 Enforcement, Alabama's highest law enforcement award for 11 extraordinary courage in the line of duty; and WHEREAS, on September 6, 2010, Officer Thigpen and 12 13 his assist were dispatched to check a suspicious vehicle parked behind a church, where there had also been a report of 14 15 a gunshot fired in the immediate area; when Officer Thigpen 16 arrived, he saw a female seated on the ground three to five feet in front of the vehicle, holding a gun to her mouth; 17 18 without hesitation, Officer Thigpen reached the female and 19 removed the weapon before she could discharge it; and 20 WHEREAS, Officer Thigpen's quick actions prevented 21 harm to a person who had already demonstrated suicidal intent 22 by firing a round just moments before he arrived on the scene; 23 his actions were remarkable in that once he recognized the 24 threat, he did not hesitate to take immediate action, which
