12 congratulations are hereby extended to Rhonda Jackson on her
13 selection as the 2010 Fraternal Order of Police Outstanding
14 Member of the Year for the State of Alabama; and

15 WHEREAS, her distinguished career in law enforcement
16 dates to 1977, when she was hired as a clerk, magistrate, and
17 dispatcher for the Town of Sylvania Police Department; and

18 WHEREAS, in 1985, she joined the DeKalb County
19 Sheriff's Department, where she progressed steadily through
20 the ranks, fulfilling each position with exceptional
21 competence and diligence; in 1989, she graduated from the
22 Police Academy in Jacksonville, Alabama; and

23 WHEREAS, in 1994, she was promoted to Investigator
24 in the DeKalb County Sheriff's Department, where she
25 specialized in cases of child abuse; in addition to the
26 compassion which characterizes her work, she is admired for
27 her readiness, ability to focus, thoroughness in follow-up,

1 toughness on alleged perpetrators, and good rapport with team
2 professionals; in 2006, she became a member of the Board of
3 Directors for the DeKalb County Multidisciplinary Child Abuse
4 Team at the Children's Advocacy Center; and

5 WHEREAS, while holding down a full-time job as
6 investigator at the DeKalb County Sheriff's Department, she
7 earned an Associate Degree in Criminal Justice; and

8 WHEREAS, in 2007, she transferred to the DeKalb
9 County Revenue Enforcement and Solid Waste Department and also
10 worked for the District Attorney's Office as an Investigator
11 on Child Abuse; and

12 WHEREAS, she has been a faithful member of the
13 Fraternal Order of Police for 20 years and has served as
14 president of Lodge 37 for five years, always unopposed; under
15 her leadership, the lodge has prospered due to her dedication
16 and hard work; among her contributions, she organizes the
17 annual fund-raisers as well as all the benefits that are held
18 for officers and families in need during times of crisis; in
19 addition to her responsibilities in the lodge, she has served
20 as Chairman for the State Easter Seals Committee for the past
21 five years; and

22 WHEREAS, although she retired in 2010 with 25 years
23 of service in law enforcement, she was reluctant to leave the
24 profession and is presently working part-time with the
25 Cherokee County Sheriff's Department Courthouse Security; and

1 WHEREAS, through the years, Rhonda Jackson has
2 earned respect for her exceptional abilities, keen intellect,
3 and unyielding integrity; now therefore,
