11 To amend Act 2010-553 in order to reduce the
12 absolute appropriation from the State General Fund to the
13 Alabama Department of Corrections in the amount of \$6,331,271
14 for the fiscal year ending September 30, 2011; to make a
15 supplemental appropriation from the DOC Miscellaneous and
16 Federal Funds (Bonus), Estimated to the Alabama Department of
17 Corrections in the amount of \$54,965,407 for the fiscal year
18 ending September 30, 2011; to make a supplemental
19 appropriation from the State General Fund to the Alabama
20 Medicaid Agency in the amount of \$125,615,631 for the fiscal
21 year ending September 30, 2011; to make a supplemental
22 appropriation from the State General Fund to the Alabama
23 Department of Senior Services in the amount of \$527,348 for
24 the fiscal year ending September 30, 2011; to make a
25 supplemental appropriation from the State General Fund to the
26 Alabama Department of Human Resources in the amount of

1 \$1,423,711 for the fiscal year ending September 30, 2011; to
2 make a supplemental appropriation from the State General Fund
3 to the Department of Mental Health in the amount of \$6,620,000
4 for the fiscal year ending September 30, 2011; to make a
5 supplemental appropriation from the State General Fund to the
6 Alabama Department of Public Health in the amount of
7 \$12,798,452 for the fiscal year ending September 30, 2011; to
8 make a supplemental appropriation from the State General Fund
9 to the Alabama Department of Rehabilitation Services in the
10 amount of \$392,402 for the fiscal year ending September 30,
11 2011; to make a supplemental appropriation from the State
12 General Fund to the Alabama Department of Youth Services in
13 the amount of \$219,304 for the fiscal year ending September
14 30, 2011; to make a supplemental appropriation from the State
15 General Fund to the Alabama Board of Pardons and Paroles in
16 the amount of \$7,844,462 for the fiscal year ending September
17 30, 2011; to make a supplemental appropriation from the State
18 General Fund to the Alabama Ethics Commission in the amount of
19 \$867,537 for the fiscal year ending September 30, 2011; to
20 make a supplemental appropriation from the State General Fund
21 to the Office of the State Auditor in the amount of \$159,002
22 for the fiscal year ending September 30, 2011; to make a
23 supplemental appropriation from the State General Fund to the
24 State Military Department in the amount of \$993,000 for the
25 fiscal year ending September 30, 2011; to make a supplemental
26 appropriation from the State General Fund to the Departmental

1 Emergency Fund in the amount of \$4,500,000 for the fiscal year
2 ending September 30, 2011; and to make a supplemental
3 appropriation from the Archives Services Fund to the
4 Department of Archives and History in the amount of \$120,000
5 for the fiscal year ending September 30, 2011; and to delete
6 certain unexpended line-item appropriations in the Department
7 of Agriculture and Industries; and to make a supplemental
8 appropriation from the State General Fund to the Alabama
9 District Attorneys in the amount of \$630,000 for the fiscal
10 year ending September 30, 2011.

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

12 Section 1. Amend Act 2010-553, Section 2C, at the
13 end of Subsection 35 entitled "Corrections, Department of:" by
14 adding the following language: "The above appropriation to the
15 Alabama Department of Corrections from the State General Fund
16 shall be reduced by \$6,331,271."

17 Section 2. In addition to all other appropriations
18 heretofore or hereafter made, there is hereby appropriated
19 \$54,965,407 from the DOC Miscellaneous and Federal Funds
20 (Bonus), Estimated to the Alabama Department of Corrections
21 for the fiscal year ending September 30, 2011.

22 Section 3. In addition to all other appropriations
23 heretofore or hereafter made, there is hereby appropriated
24 \$125,615,631 from the State General Fund to the Alabama
25 Medicaid Agency for the fiscal year ending September 30, 2011.

1 Section 4. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$527,348 from the State General Fund to the Alabama Department
4 of Senior Services for the fiscal year ending September 30,
5 2011.

6 Section 5. In addition to all other appropriations
7 heretofore or hereafter made, there is hereby appropriated
8 \$1,423,711 from the State General Fund to the Alabama
9 Department of Human Resources for the fiscal year ending
10 September 30, 2011.

11 Section 6. In addition to all other appropriations
12 heretofore or hereafter made, there is hereby appropriated
13 \$6,620,000 from the State General Fund to the Alabama
14 Department of Mental Health for the fiscal year ending
15 September 30, 2011.

16 Section 7. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$12,798,452 from the State General Fund to the Alabama
19 Department of Public Health for the fiscal year ending
20 September 30, 2011.

21 Section 8. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$392,402 from the State General Fund to the Alabama Department
24 of Rehabilitation Services for the fiscal year ending
25 September 30, 2011.

1 Section 9. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$219,304 from the State General Fund to the Alabama Department
4 of Youth Services for the fiscal year ending September 30,
5 2011.

6 Section 10. In addition to all other appropriations
7 heretofore or hereafter made, there is hereby appropriated
8 \$7,844,462 from the State General Fund to the Alabama Board of
9 Pardons and Paroles for the fiscal year ending September 30,
10 2011.

11 Section 11. In addition to all other appropriations
12 heretofore or hereafter made, there is hereby appropriated
13 \$867,537 from the State General Fund to the Alabama Ethics
14 Commission for the fiscal year ending September 30, 2011.

15 Section 12. In addition to all other appropriations
16 heretofore or hereafter made, there is hereby appropriated
17 \$159,002 from the State General Fund to the Office of the
18 State Auditor for the fiscal year ending September 30, 2011.

19 Section 13. In addition to all other appropriations
20 heretofore or hereafter made, there is hereby appropriated
21 \$993,000 from the State General Fund to the State Military
22 Department for the fiscal year ending September 30, 2011.

23 Section 14. In addition to all other appropriations
24 heretofore or hereafter made, there is hereby appropriated
25 \$4,500,000 from the State General Fund to the Departmental
26 Emergency Fund for the fiscal year ending September 30, 2011.

1 Section 15. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$630,000 from the State General Fund to the Alabama District
4 Attorneys for the fiscal year ending September 30, 2011.

5 Section 16. On the effective date of this act, any
6 unexpended funds from line-item appropriations under the
7 Department of Agriculture and Industries for the following
8 shall be reverted to the Administrative Services Program of
9 the Department of Agriculture and Industries: Farm and Ranch
10 Lands Protection Program; expenses and awarding of prizes for
11 fairs as provided in Section 2-7-21, Code of Alabama 1975, and
12 other livestock shows exhibits and the Livestock Coliseum and
13 other activities as deemed necessary by the Agricultural
14 Center Board; Treasure Forest Program; Center for Alternative
15 Fuels; rabbit production and promotion; and the North Alabama
16 Agriplex.

17 Section 17. In addition to all other appropriations
18 heretofore or hereafter made, there is hereby appropriated
19 \$120,000 from the Archives Services Fund to the Department of
20 Archives and History for the fiscal year ending September 30,
21 2011.

22 Section 18. This act shall become effective
23 immediately upon its passage and approval by the Governor, or
24 upon its otherwise becoming law.
