BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Amend Act 2010-553, Section 2C, at the end of Subsection 35 entitled "Corrections, Department of:" by adding the following language: "The above appropriation to the Alabama Department of Corrections from the State General Fund shall be reduced by \$6,331,271."

Section 2. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$54,965,407 from the DOC Miscellaneous and Federal Funds (Bonus), Estimated to the Alabama Department of Corrections for the fiscal year ending September 30, 2011.

Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$125,615,631 from the State General Fund to the Alabama Medicaid Agency for the fiscal year ending September 30, 2011.

Section 4. In addition to all other appropriations
heretofore or hereafter made, there is hereby appropriated

\$527,348 from the State General Fund to the Alabama Department
of Senior Services for the fiscal year ending September 30,

2011.

Section 5. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$1,423,711 from the State General Fund to the Alabama Department of Human Resources for the fiscal year ending September 30, 2011.

Section 6. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$6,620,000 from the State General Fund to the Alabama Department of Mental Health for the fiscal year ending September 30, 2011.

Section 7. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$12,798,452 from the State General Fund to the Alabama Department of Public Health for the fiscal year ending September 30, 2011.

Section 8. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$392,402 from the State General Fund to the Alabama Department of Rehabilitation Services for the fiscal year ending September 30, 2011.

Section 9. In addition to all other appropriations
heretofore or hereafter made, there is hereby appropriated

\$219,304 from the State General Fund to the Alabama Department
of Youth Services for the fiscal year ending September 30,

2011.

Section 10. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$7,844,462 from the State General Fund to the Alabama Board of Pardons and Paroles for the fiscal year ending September 30, 2011.

Section 11. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$867,537 from the State General Fund to the Alabama Ethics Commission for the fiscal year ending September 30, 2011.

Section 12. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$159,002 from the State General Fund to the Office of the State Auditor for the fiscal year ending September 30, 2011.

Section 13. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$993,000 from the State General Fund to the State Military Department for the fiscal year ending September 30, 2011.

Section 14. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$4,500,000 from the State General Fund to the Departmental Emergency Fund for the fiscal year ending September 30, 2011.

Section 15. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$630,000 from the State General Fund to the Alabama District Attorneys for the fiscal year ending September 30, 2011.

Section 16. On the effective date of this act, any unexpended funds from line-item appropriations under the Department of Agriculture and Industries for the following shall be reverted to the Administrative Services Program of the Department of Agriculture and Industries: Farm and Ranch Lands Protection Program; expenses and awarding of prizes for fairs as provided in Section 2-7-21, Code of Alabama 1975, and other livestock shows exhibits and the Livestock Coliseum and other activities as deemed necessary by the Agricultural Center Board; Treasure Forest Program; Center for Alternative Fuels; rabbit production and promotion; and the North Alabama Agriplex.

Section 17. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$120,000 from the Archives Services Fund to the Department of Archives and History for the fiscal year ending September 30, 2011.

Section 18. This act shall become effective immediately upon its passage and approval by the Governor, or upon its otherwise becoming law.
