8 SYNOPSIS: This bill amends Act 2010-553 in order to  
9 reduce the absolute appropriation from the State  
10 General Fund to the Alabama Department of  
11 Corrections in the amount of \$6,331,271 for the  
12 fiscal year ending September 30, 2011; makes a  
13 supplemental appropriation from the DOC  
14 Miscellaneous and Federal Funds (Bonus), Estimated  
15 to the Alabama Department of Corrections in the  
16 amount of \$54,965,407 for the fiscal year ending  
17 September 30, 2011; a supplemental appropriation  
18 from the State General Fund to the Alabama Medicaid  
19 Agency in the amount of \$125,615,631 for the fiscal  
20 year ending September 30, 2011; a supplemental  
21 appropriation from the State General Fund to the  
22 Alabama Department of Senior Services in the amount  
23 of \$527,348 for the fiscal year ending September  
24 30, 2011; a supplemental appropriation from the  
25 State General Fund to the Alabama Department of  
26 Human Resources in the amount of \$1,423,711 for the  
27 fiscal year ending September 30, 2011; a

11 To amend Act 2010-553 in order to reduce the  
12 absolute appropriation from the State General Fund to the  
13 Alabama Department of Corrections in the amount of \$6,331,271  
14 for the fiscal year ending September 30, 2011; to make a  
15 supplemental appropriation from the DOC Miscellaneous and  
16 Federal Funds (Bonus), Estimated to the Alabama Department of  
17 Corrections in the amount of \$54,965,407 for the fiscal year  
18 ending September 30, 2011; to make a supplemental  
19 appropriation from the State General Fund to the Alabama  
20 Medicaid Agency in the amount of \$125,615,631 for the fiscal  
21 year ending September 30, 2011; to make a supplemental  
22 appropriation from the State General Fund to the Alabama  
23 Department of Senior Services in the amount of \$527,348 for  
24 the fiscal year ending September 30, 2011; to make a  
25 supplemental appropriation from the State General Fund to the  
26 Alabama Department of Human Resources in the amount of  
27 \$1,423,711 for the fiscal year ending September 30, 2011; to

1 make a supplemental appropriation from the State General Fund  
2 to the Department of Mental Health in the amount of \$6,620,000

15 the amount of \$7,844,462 for the fiscal year ending September  
16 30, 2011; to make a supplemental appropriation from the State  
17 General Fund to the Alabama Ethics Commission in the amount of  
18 \$376,537 for the fiscal year ending September 30, 2011; to  
19 make a supplemental appropriation from the State General Fund  
20 to the Office of the State Auditor in the amount of \$159,002  
21 for the fiscal year ending September 30, 2011; to make a  
22 supplemental appropriation from the State General Fund to the  
23 State Military Department in the amount of \$993,000 for the  
24 fiscal year ending September 30, 2011; and to make a  
25 supplemental appropriation from the State General Fund to the  
26 Departmental Emergency Fund in the amount of \$5,000,000 for  
27 the fiscal year ending September 30, 2011.

1 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

2 Section 1. Amend Act 2010-553, Section 2C, after  
3 Subsection 35 entitled "Corrections, Department of:" by adding  
4 the following language: "The above appropriation to the  
5 Alabama Department of Corrections from the State General Fund  
6 shall be reduced by \$6,331,271."

7 Section 2. In addition to all other appropriations  
8 heretofore or hereafter made, there is hereby appropriated  
9 \$54,965,407 from the DOC Miscellaneous and Federal Funds  
10 (Bonus), Estimated to the Alabama Department of Corrections  
11 for the fiscal year ending September 30, 2011.

12 Section 3. In addition to all other appropriations  
13 heretofore or hereafter made, there is hereby appropriated  
14 \$125,615,631 from the State General Fund to the Alabama  
15 Medicaid Agency for the fiscal year ending September 30, 2011.

16 Section 4. In addition to all other appropriations  
17 heretofore or hereafter made, there is hereby appropriated  
18 \$527,348 from the State General Fund to the Alabama Department  
19 of Senior Services for the fiscal year ending September 30,  
20 2011.

21 Section 5. In addition to all other appropriations  
22 heretofore or hereafter made, there is hereby appropriated  
23 \$1,423,711 from the State General Fund to the Alabama  
24 Department of Human Resources for the fiscal year ending  
25 September 30, 2011.

26 Section 6. In addition to all other appropriations  
27 heretofore or hereafter made, there is hereby appropriated

1 \$6,620,000 from the State General Fund to the Alabama  
2 Department of Mental Health for the fiscal year ending  
3 September 30, 2011.

4 Section 7. In addition to all other appropriations  
5 heretofore or hereafter made, there is hereby appropriated  
6 \$12,798,452 from the State General Fund to the Alabama  
7 Department of Public Health for the fiscal year ending  
8 September 30, 2011.

9 Section 8. In addition to all other appropriations  
10 heretofore or hereafter made, there is hereby appropriated  
11 \$392,402 from the State General Fund to the Alabama Department  
12 of Rehabilitation Services for the fiscal year ending  
13 September 30, 2011.

14 Section 9. In addition to all other appropriations  
15 heretofore or hereafter made, there is hereby appropriated  
16 \$219,304 from the State General Fund to the Alabama Department  
17 of Youth Services for the fiscal year ending September 30,  
18 2011.

19 Section 10. In addition to all other appropriations  
20 heretofore or hereafter made, there is hereby appropriated  
21 \$7,844,462 from the State General Fund to the Alabama  
22 Department of Pardons and Paroles for the fiscal year ending  
23 September 30, 2011.

24 Section 11. In addition to all other appropriations  
25 heretofore or hereafter made, there is hereby appropriated  
26 \$376,537 from the State General Fund to the Alabama Ethics  
27 Commission for the fiscal year ending September 30, 2011.

1           Section 12. In addition to all other appropriations  
2 heretofore or hereafter made, there is hereby appropriated  
3 \$159,002 from the State General Fund to the Office of the  
4 State Auditor for the fiscal year ending September 30, 2011.

5           Section 13. In addition to all other appropriations  
6 heretofore or hereafter made, there is hereby appropriated  
7 \$993,000 from the State General Fund to the State Military  
8 Department for the fiscal year ending September 30, 2011.

9           Section 14. In addition to all other appropriations  
10 heretofore or hereafter made, there is hereby appropriated  
11 \$5,000,000 from the State General Fund to the Departmental  
12 Emergency Fund for the fiscal year ending September 30, 2011.

13           Section 15. This act shall become effective  
14 immediately upon its passage and approval by the Governor, or  
15 upon its otherwise becoming law.
