25	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
26	Section 1. Sections 16-24-11 and 16-24-12 of the
27	Code of Alabama 1975, are amended to read as follows:

"\$16-24-11.

"No teacher, whether in continuing service status or not, shall be permitted to cancel his or her contract during the school term for which said contract is in effect, nor for a period of 45 30 calendar days previous to the beginning of such school term, unless such cancellation is mutually agreed upon; any such teacher shall be permitted to cancel his or her contract at any other time by giving five days' written notice to the employing board of education. Any teacher cancelling his or her contract in any other manner than in this section provided shall be deemed guilty of unprofessional conduct, and the State Superintendent of Education is hereby authorized to revoke or suspend the certificate of such teacher.

"\$16-24-12.

"Any teacher in the public schools, whether in continuing service status or not, shall be deemed offered reemployment for the succeeding school year at the same salary unless the employing board of education shall cause notice in writing to be given said the teacher on or before the last day of the term of the school in which the teacher is employed, except in the first year of each legislative quadrennium the written notice to the teacher shall be provided on or before June 30; and such teacher shall be presumed to have accepted such employment unless he or she shall notify the employing board of education in writing to the contrary on or before the fifteenth day of June 30 calendar days before the first day of the school term. The employing board of education shall not

cancel the contract of any teacher in continuing service 1 2 status, nor cause notice of nonemployment to be given to any teacher whether in continuing service status or not except by 3 a vote of a majority of its members evidenced by the minute entries of said the board made prior to or at the time of any 5 such action." 6 7 Section 2. This act shall become effective immediately following its passage and approval by the 8 Governor, or its otherwise becoming law. 9
