4 ENROLLED, An Act,

5 To amend Section 2-6-12 of the Code of Alabama 1975,
6 providing for a continuing annual appropriation under certain
7 conditions to the Agriculture Center Board for the purpose of
8 renovating Garrett Coliseum, to delay the beginning fiscal
9 year of the appropriations.

10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

11 Section 1. Section 2-6-12 of the Code of Alabama
12 1975, is amended to read as follows:

13 "§2-6-12.

14 "(a) Beginning in the fiscal year ending September
15 30, 2013, and in each fiscal year thereafter there shall be
16 appropriated from the State General Fund to the Alabama
17 Agriculture Center Board the sum of eight hundred thousand
18 dollars (\$800,000).

19 "(b) This annual appropriation shall be in addition
20 to any and all other appropriations to the Alabama Agriculture
21 Center Board. The annual appropriation to the board in the
22 amount of eight hundred thousand dollars (\$800,000) shall
23 continue in each succeeding fiscal year as long as a
24 restoration, renovation, and improvement agreement of at least
25 thirty million dollars (\$30,000,000) remains in effect between

1 the board and any public institution or corporation of the
2 State of Alabama for the renovation and rehabilitation of
3 Garrett Coliseum and the Alabama Agriculture Center, located
4 in Montgomery, Alabama.

5 "(c) In the fiscal year following the expiration or
6 termination of the above agreement, the provisions of this
7 continuing appropriation shall cease. However, in any event,
8 the continuing appropriation shall cease and no longer be in
9 effect after fiscal year 2042.

10 "(d) The appropriation authority granted in this
11 article shall become null and void after September 30, 2015,
12 if by that time the board has not entered into a restoration,
13 renovation, and improvement agreement with any public
14 institution or other entity through which the use of private
15 funding is primarily used to restore, renovate, and improve
16 the facility."

17 Section 2. This act shall become effective
18 immediately following its passage and approval by the
19 Governor, or its otherwise becoming law.
