9 Honorable Pedro Scurlock, District Judge of Choctaw County, is

12 1986, he spent 12 years in private practice; during his years
13 on the bench, he has also served as a Circuit Judge by
14 appointment on numerous occasions in Clarke, Choctaw,
15 Washington, Sumter, Marengo, and Greene Counties; in addition,
16 he worked for 11 years as an Assistant District Attorney; and

17 WHEREAS, a 1964 graduate of Choctaw County High
18 School and a 1972 graduate of the University of South Alabama
19 with a degree in Criminal Justice, Judge Scurlock graduated
20 from The University of Alabama School of Law in 1975 with a
21 Juris Doctorate Degree; and

22 WHEREAS, he is a Vietnam veteran who was stationed
23 at a United States Navy Naval Construction (SeaBees) Battalion
24 located between Da Nang and Marble Mountain, South Vietnam; he
25 served as a Construction Electrician (Third Class) and as an

1 Assistant Gunner on an 81mm mortar squad; he was honorably
2 discharged in 1969; and

3 WHEREAS, Judge Scurlock is married to the former
4 JoAnn Lovette of the Red Springs community and they have one
5 son, Wallace Andrew Scurlock; and

6 WHEREAS, throughout his exemplary career, Judge
7 Scurlock has earned respect for his outstanding capability,
8 integrity, and tireless dedication; now therefore,

9 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
10 HOUSES THEREOF CONCURRING, That on the occasion of his
11 retirement and in recognition of his dedicated service,
12 highest commendation is herein extended to the Honorable Pedro
