ENROLLED, An Act,

Relating to Marshall County; to amend Section 1 of Act 2011-527, 2011 Regular Session, providing for the distribution of additional TVA in-lieu-of-taxes payments received by the county pursuant to Act 2010-135 to the school systems in the county for payments to teachers achieving National Board Certification.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. (a) The increase in TVA in-lieu-of-taxes payments to Marshall County generated by Act 2010-135, 2010 Regular Session, to the counties served by the TVA shall be distributed as follows:

(1) Twenty-five percent of the total amount to the Marshall County Board of Education, the Arab City Board of Education, the Guntersville City Board of Education, the Albertville City Board of Education, and the Boaz City Board of Education on a per pupil basis based upon the student enrollment of the respective school systems on the last day of the first monthly attendance report of each school year. If the amount to paid to teachers who have achieved National Board Certification by this state is less than five thousand dollars (\$5,000), these funds shall be used to pay teachers the difference in the amount paid and five thousand dollars

1 (\$5,000) each year. Any remaining funds may be used at the
2 discretion of the board.

3 (2) Seventy-five percent to a county discretionary
4 fund. Moneys in the discretionary fund may be expended for any
5 lawful purpose by warrant drawn upon the fund pursuant to the
6 direction of a discretionary fund committee.

7 (b) The Discretionary Fund Committee is created. The
8 committee shall be comprised of three members as follows:

9 (1) One member who is a resident of Marshall County,
10 to be appointed by the state Senator representing Marshall
11 County.

12 (2) Two members, one to be appointed by each of the
13 members of the House of Representatives representing Marshall
14 County. Each of these members shall be a resident of the
15 legislative district of the respective appointing House
16 member.

17 (c) The distributions made pursuant to this act
18 shall be made separate and apart from all other TVA
19 in-lieu-of-taxes payments required by Marshall County,
20 including, but not limited to, those payments distributed
21 pursuant to Act 2007-498, 2007 Regular Session.

22 Section 2. This act shall become effective
23 immediately following its passage and approval by the
24 Governor, or its otherwise becoming law.
