6 news of the death of Mr. Jimmy Paul Reeves of Sulligent,
7 Alabama, on January 28, 2012, at the age of 79 years; and

8 WHEREAS, the passing of Mr. Reeves leaves a void in
9 the lives of his loving family, his many friends, and the
10 entire community, where he was highly regarded; he was a
11 veteran who served with honor and distinction in the United
12 States Army during the Korean War; and

16 served as a deacon; Mr. Reeves was employed as an accountant

23 Reeves; brothers, Carl (Sybil) Reeves, Jerry (Pat) Reeves, and
24 Brock (Linda) Reeves; and sisters, Polly (Frank) Mixon and

2 predeceased by two infant brothers; and

3 WHEREAS, Mr. Reeves was a valued member of the
4 community; although his presence will be greatly missed, his
5 memory will be cherished in the hearts and minds of those who
