ENROLLED, House Joint Resolution,
NAMING A PORTION OF UNITED STATES HIGHWAY 90 IN
BALDWIN COUNTY, ALABAMA, THE "SAMUEL JENKINS, SR., HIGHWAY."

WHEREAS, it is with the highest commendation that in
Baldwin County, Alabama, we recommend naming a portion of
United States (U.S.) Highway 90, from the intersection of U.S.
Highway 90 and Baldwin County Road 13, to the intersection of
U.S. Highway 90 and State Highway 181, the "Samuel Jenkins,
Sr., Highway"; and

WHEREAS, Samuel Jenkins, Sr., was the first
African-American to be elected to the Baldwin County
Commission and the first African-American Baldwin County
Commission Chair; and

WHEREAS, throughout his life, Samuel Jenkins, Sr.,
has been involved in selfless service to the Baldwin County
citizens on the Eastern Shore of Baldwin County and throughout
the county; and

WHEREAS, in recognition of the leadership and
service of Samuel Jenkins, Sr., it is befitting that a portion
of United States (U.S.) Highway 90 from the intersection of
U.S. Highway 90 and Baldwin County Road 13, to the
intersection of U.S. Highway 90 and State Highway 181, be

1 named the "Samuel Jenkins, Sr., Highway" as an enduring and
2 lasting tribute; now therefore,

3 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
4 HOUSES THEREOF CONCURRING, That we do hereby name that portion
5 of United States (U.S.) Highway 90 from the intersection of
6 U.S. Highway 90 and Baldwin County Road 13 to the intersection
7 of U.S. Highway 90 and State Highway 181, the "Samuel Jenkins,
8 Sr., Highway" and request the appropriate official to place
9 and maintain signs or markers as provided in this resolution.

10 BE IT FURTHER RESOLVED, That a copy of this
11 resolution be provided to Samuel Jenkins, Sr., so that this
12 meritorious designation is known.
