3 DESIGNATING A PORTION OF ALABAMA HIGHWAY 27 IN  
4 GENEVA SOUTHBOUND TO THE STATE OF FLORIDA BOUNDARY LINE AS THE  
5 SHERIFF LELON D. SIZEMORE OF GENEVA COUNTY MEMORIAL HIGHWAY.

7 WHEREAS, with highest tribute and deepest  
8 appreciation, the service of the late Sheriff Lelon D. "Red"  
9 Sizemore of Geneva County is herein recognized and honored;  
10 and

11 WHEREAS, Sheriff Sizemore lost his life in the line  
12 of duty, while arresting an intoxicated man for disorderly  
13 conduct; and

14 WHEREAS, the life of Sheriff Lelon D. "Red" Sizemore  
15 was dedicated to the service and protection of his fellowman;  
16 there is no higher calling or greater sacrifice, and his  
17 memory will be cherished in the hearts and minds of those who  
18 were fortunate to know him during his lifetime; now therefore,

19 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
20 HOUSES THEREOF CONCURRING, That the portion of Alabama Highway  
21 27 in Geneva County southbound to the State of Florida  
22 boundary line is designated the Sheriff Lelon D. "Red"  
23 Sizemore Memorial Highway.

1           BE IT FURTHER RESOLVED, That, if possible, the  
2 signage should be designed and laid out in emblems and words  
3 as follows:

4           Great Seal of the State of Alabama

5           Sheriff Lelon D. "Red" Sizemore Memorial Highway.

6           BE IT FURTHER RESOLVED, That such memorial  
7 designation shall in no way alter or conflict with the common  
8 designation Alabama Highway 27 in Geneva County southbound to  
9 the State of Florida line and shall not affect in any way  
10 postal or address designations along that portion of Alabama  
11 Highway 27 in Geneva southbound to the State of Florida line  
12 to be so memorialized.

13           BE IT FURTHER RESOLVED, That a copy of this  
14 resolution be presented to the immediate family of Sheriff  
15 Lelon D. "Red" Sizemore, so that they may know of the esteem  
16 in which we hold their fallen family member and the service he  
17 made to his country, his state, and Geneva County.
