4 ENROLLED, An Act,

5 To make a supplemental appropriation in the amount
6 of \$2,313,850 from the Education Trust Fund to the State
7 Department of Education for the fiscal year ending September
8 30, 2012, to pay the entire \$5,000 salary supplement to
9 teachers for the fiscal years 2010-2011 and 2011-2012 who
10 complete the process to become certified by the National Board
11 of Professional Teaching Standards; and to authorize the
12 payment of the same annual salary supplement provided for
13 teachers for any principal who receives national board
14 certification.

15 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

16 Section 1. There is hereby appropriated two million
17 three hundred thirteen thousand eight hundred fifty dollars
18 (\$2,313,850) from the Education Trust Fund to the State
19 Department of Education to ensure that for the fiscal years
20 2010-2011 and 2011-2012 the entire five thousand dollar
21 (\$5,000) salary supplement to teachers who complete the
22 process to become certified by the National Board of
23 Professional Teaching Standards be paid in the fiscal year
24 ending September 30, 2012.

1 Section 2. Commencing on January 1, 2013, any public
2 elementary or secondary school principal who receives national
3 board certification from the National Board for Professional
4 Teaching Standards shall receive the same annual stipend or
5 supplement as is provided for public school teachers and
6 public school counselors who have received certification from
7 the National Board for Professional Teaching Standards.
8 Nothing in this section shall imply or be interpreted as a
9 right to any additional compensation for any prior school
10 year.

11 Section 3. This act shall become effective
12 immediately following its passage and approval by the
13 Governor, or its otherwise becoming law.
