9		owner or operator to submit an annual report to the
10		Department of Public Health detailing the total
11		number of animals that have entered the facility

13		Amendment 621 of the Constitution of Alabama
14		of 1901, now appearing as Section 111.05 of the
15		Official Recompilation of the Constitution of
16		Alabama of 1901, as amended, prohibits a general
17		law whose purpose or effect would be to require a
18		new or increased expenditure of local funds from
19		becoming effective with regard to a local
20		governmental entity without enactment by a 2/3 vote
21		unless: it comes within one of a number of
22		specified exceptions; it is approved by the
23		affected entity; or the Legislature appropriates
24		funds, or provides a local source of revenue, to
25		the entity for the purpose.
26		The purpose or effect of this bill would be
27		to require a new or increased expenditure of local

1	funds within the meaning of the amendment. However,	
2	the bill does not require approval of a local	
3	governmental entity or enactment by a 2/3 vote to	
4	become effective because it comes within one of the	
5	specified exceptions contained in the amendment.

11	Relating to animal control; to require an animal	
12	shelter owner or operator to submit an annual report to the	
13	Department of Public Health detailing the total number of

15	the animals; and in connection therewith would have as its	
16	purpose or effect the requirement of a new or increased	
17	expenditure of local funds within the meaning of Amendment 62	
18	of the Constitution of Alabama of 1901, now appearing as	
19	Section 111.05 of the Official Recompilation of the	
20	Constitution of Alabama of 1901, as amended.	
21	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:	
22	Section 1. This act shall be known and cited as the	
23	"Alabama Animal Control System Accountability Act."	
24	Section 2. The following words shall have the	
25	following meanings:	
26	(1) ANIMAL SHELTER. Any facility operated in whole	
27	or in part for the purpose of impounding or harboring seized,	

- stray, homeless, abandoned, or unwanted dogs, cats, or other

 pets, including any facility operated, owned, controlled, or

 maintained by a duly incorporated humane society or

 organization designed to prevent animal cruelty, a for-profit

 or not-for-profit rescue organization, or any person who

 serves the same purpose as a humane society or organization to

 prevent animal cruelty.
- 8 (2) DEPARTMENT. The State Department of Public 9 Health.
- 10 (3) REPORTED YEAR. Calendar year for which a report 11 is made.
 - Section 3. On an annual basis, each animal shelter operator shall submit to the department a report that details the total number of animals of each species that have been:
 - (1) Adopted.

- (2) Released to or claimed by the owner or owners.
- (3) Transferred to other facilities or released to rescue organizations. The name of the facility or rescue organization shall be reported.
- (4) Euthanized or have died from causes other than euthanasia while in the custody of the animal shelter.
- (5) Sold, bartered, brokered, or transferred to a research laboratory, school, college, university, or agency that supplies or sells animals to these facilities whether for profit or not for profit.
- (6) Found to be sterilized upon arrival at the shelter.

1 (7) Sterilized after arrival by personnel of the 2 shelter or contract veterinarian.

- (b) The department shall develop and provide a standard reporting form accessible to all animal shelter operators. The form shall include a statement that the author of the report certifies it to be true and correct.
- (c) The department may charge animal shelters a reasonable fee to cover the cost of collecting and processing the reports. The department may charge any person who requests a report any cost associated with reproducing and mailing the report.

Section 4. The department shall compile these reports on a statewide and county by county basis. Reports shall be kept and maintained by the department for at least five years. Reports made under this act shall be considered public record and access to the reports shall not be denied pursuant to any exemption under the Freedom of Information Act.

Section 5. Any person who is required to file a report and fails to do so during the reporting period, or who knowingly makes or submits a false or fraudulent report required under this act, is guilty of a Class A misdemeanor.

Section 6. The department shall promulgate rules to administer and enforce this act.

Section 7. Although this bill would have as its purpose or effect the requirement of a new or increased expenditure of local funds, the bill is excluded from further

requirements and application under Amendment 621, now
appearing as Section 111.05 of the Official Recompilation of
the Constitution of Alabama of 1901, as amended, because the
bill defines a new crime or amends the definition of an
existing crime.

Section 8. This act shall become effective on the
first day of the third month following its passage and

approval by the Governor, or its otherwise becoming law.

8
