ENROLLED, An Act,

To make a supplemental appropriation from the Education Trust Fund to the Department of Rehabilitation Services in the amount of \$1,000,000 for the fiscal year ending September 30, 2013; to make a supplemental appropriation from the Education Trust Fund to the Alabama Institute for Deaf and Blind in the amount of \$1,000,000 for the fiscal year ending September 30, 2013; to make a supplemental appropriation from the Education Trust Fund to the Department of Archives and History in the amount of \$400,000 for the fiscal year ending September 30, 2013; to make a supplemental appropriation from the Education Trust Fund to the Legislature in the amount of \$500,000 for the fiscal year ending September 30, 2013; to make a supplemental appropriation from the Education Trust Fund to the Public Library Service in the amount of \$250,000 for the fiscal year ending September 30, 2013; to make a supplemental appropriation from the Education Trust Fund to the Alabama School of Mathematics and Science in the amount of \$150,000 for the fiscal year ending September 30, 2013; to make a supplemental appropriation from the Education Trust Fund to the Alabama School of Fine Arts in the amount of \$150,000 for the fiscal year ending September 30, 2013; and to make a supplemental appropriation from the Education Trust Fund to

1 the Department of Homeland Security in the amount of \$430,000
2 for the fiscal year ending September 30, 2013.

3 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

4 Section 1. In addition to all other appropriations
5 heretofore or hereafter made, there is hereby appropriated
6 \$1,000,000 from the Education Trust Fund to the Department of
7 Rehabilitation Services for the fiscal year ending September
8 30, 2013.

9 Section 2. In addition to all other appropriations
10 heretofore or hereafter made, there is hereby appropriated
11 \$1,000,000 from the Education Trust Fund to the Alabama
12 Institute for Deaf and Blind for the fiscal year ending
13 September 30, 2013.

14 Section 3. In addition to all other appropriations
15 heretofore or hereafter made, there is hereby appropriated
16 \$400,000 from the Education Trust Fund to the Department of
17 Archives and History for the fiscal year ending September 30,
18 2013.

19 Section 4. In addition to all other appropriations
20 heretofore or hereafter made, there is hereby appropriated
21 \$500,000 from the Education Trust Fund to the Legislature for
22 the fiscal year ending September 30, 2013.

23 Section 5. In addition to all other appropriations
24 heretofore or hereafter made, there is hereby appropriated

1 \$250,000 from the Education Trust Fund to the Public Library
 2 Service for the fiscal year ending September 30, 2013.

3 Section 6. In addition to all other appropriations
 4 heretofore or hereafter made, there is hereby appropriated
 5 \$150,000 from the Education Trust Fund to the Alabama School
 6 of Mathematics and Science for the fiscal year ending
 7 September 30, 2013.

8 Section 7. In addition to all other appropriations
 9 heretofore or hereafter made, there is hereby appropriated
 10 \$150,000 from the Education Trust Fund to the Alabama School
 11 of Fine Arts for the fiscal year ending September 30, 2013.

12 Section 8. In addition to all other appropriations
 13 heretofore or hereafter made, there is hereby appropriated
 14 \$430,000 from the Education Trust Fund to the Department of
 15 Homeland Security for the fiscal year ending September 30,
 16 2013. This appropriation shall be expended to expand active
 17 shooter training and Virtual Alabama.

18 Section 9. In addition to all other appropriations
 19 heretofore or hereafter made, there is hereby appropriated
 20 \$2,316,462 from the Education Technology Fund to the State
 21 Department of Education for the Alabama Science in Motion
 22 Program for the fiscal year ending September 30, 2013.

23 Section 10. Notwithstanding any other provisions of
 24 law, any amount from appropriations for the fiscal year ending
 25 September 30, 2013 to the various state agencies and

1 institutions in this bill which are unexpended and reverted on
2 September 30, 2013 are hereby reappropriated to the respective
3 agencies and institutions for the fiscal year beginning
4 October 1, 2013.

5 Section 11. This act shall become effective
6 immediately upon its passage and approval by the Governor, or
7 upon its otherwise becoming law.
