fiscal year ending September 30, 2013; to make a supplemental 1 2 appropriation from the Education Trust Fund to the Public Library Service in the amount of \$250,000 for the fiscal year 3 ending September 30, 2013; to make a supplemental appropriation from the Education Trust Fund to the Alabama School of Mathematics and Science in the amount of \$150,000 6 7 for the fiscal year ending September 30, 2013; to make a supplemental appropriation from the Education Trust Fund to 8 the Alabama School of Fine Arts in the amount of \$150,000 for 9 the fiscal year ending September 30, 2013; and to make a supplemental appropriation from the Education Trust Fund to 11 the Department of Homeland Security in the amount of \$430,000 12 13 for the fiscal year ending September 30, 2013.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$1,000,000 from the Education Trust Fund to the Department of Rehabilitation Services for the fiscal year ending September 30, 2013.

Section 2. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$1,000,000 from the Education Trust Fund to the Alabama Institute for Deaf and Blind for the fiscal year ending September 30, 2013.

Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$400,000 from the Education Trust Fund to the Department of

Archives and History for the fiscal year ending September 30, 2 2013.

Section 4. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$500,000 from the Education Trust Fund to the Legislature for the fiscal year ending September 30, 2013.

Section 5. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$250,000 from the Education Trust Fund to the Public Library Service for the fiscal year ending September 30, 2013.

Section 6. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$150,000 from the Education Trust Fund to the Alabama School of Mathematics and Science for the fiscal year ending September 30, 2013.

Section 7. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$150,000 from the Education Trust Fund to the Alabama School of Fine Arts for the fiscal year ending September 30, 2013.

Section 8. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$430,000 from the Education Trust Fund to the Department of Homeland Security for the fiscal year ending September 30, 2013. This appropriation shall be expended to expand active shooter training and Virtual Alabama.

Section 9. Notwithstanding any other provisions of law, any amount from appropriations for the fiscal year ending

1 September 30, 2013 to the various state agencies and 2 institutions in this bill which are unexpended and reverted on September 30, 2013 are hereby reappropriated to the respective 3 agencies and institutions for the fiscal year beginning 4 5 October 1, 2013. Section 10. This act shall become effective 6 7 immediately upon its passage and approval by the Governor, or upon its otherwise becoming law. 8
