8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the Education Trust Fund to the Department of
10 Rehabilitation Services in the amount of \$1,000,000
11 for the fiscal year ending September 30, 2013;
12 makes a supplemental appropriation from the
13 Education Trust Fund to the Alabama Institute for
14 Deaf and Blind in the amount of \$1,000,000 for the
15 fiscal year ending September 30, 2013; makes a
16 supplemental appropriation from the Education Trust
17 Fund to the Department of Archives and History in
18 the amount of \$400,000 for the fiscal year ending
19 September 30, 2013; makes a supplemental
20 appropriation from the Education Trust Fund to the
21 Legislature in the amount of \$500,000 for the
22 fiscal year ending September 30, 2013; makes a
23 supplemental appropriation from the Education Trust
24 Fund to the Public Library Service in the amount of
25 \$250,000 for the fiscal year ending September 30,
26 2013; makes a supplemental appropriation from the
27 Education Trust Fund to the Alabama School of

1 Mathematics and Science in the amount of \$150,000
2 for the fiscal year ending September 30, 2013;
3 makes a supplemental appropriation from the
4 Education Trust Fund to the Alabama School of Fine
5 Arts in the amount of \$150,000 for the fiscal year
6 ending September 30, 2013; and makes a supplemental
7 appropriation from the Education Trust Fund to the
8 Department of Homeland Security in the amount of
9 \$430,000 for the fiscal year ending September 30,
10 2013.

16 To make a supplemental appropriation from the
17 Education Trust Fund to the Department of Rehabilitation
18 Services in the amount of \$1,000,000 for the fiscal year
19 ending September 30, 2013; to make a supplemental
20 appropriation from the Education Trust Fund to the Alabama
21 Institute for Deaf and Blind in the amount of \$1,000,000 for
22 the fiscal year ending September 30, 2013; to make a
23 supplemental appropriation from the Education Trust Fund to
24 the Department of Archives and History in the amount of
25 \$400,000 for the fiscal year ending September 30, 2013; to
26 make a supplemental appropriation from the Education Trust
27 Fund to the Legislature in the amount of \$500,000 for the

1 fiscal year ending September 30, 2013; to make a supplemental
2 appropriation from the Education Trust Fund to the Public
3 Library Service in the amount of \$250,000 for the fiscal year
4 ending September 30, 2013; to make a supplemental
5 appropriation from the Education Trust Fund to the Alabama
6 School of Mathematics and Science in the amount of \$150,000
7 for the fiscal year ending September 30, 2013; to make a
8 supplemental appropriation from the Education Trust Fund to
9 the Alabama School of Fine Arts in the amount of \$150,000 for
10 the fiscal year ending September 30, 2013; and to make a
11 supplemental appropriation from the Education Trust Fund to
12 the Department of Homeland Security in the amount of \$430,000
13 for the fiscal year ending September 30, 2013.

14 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

15 Section 1. In addition to all other appropriations
16 heretofore or hereafter made, there is hereby appropriated
17 \$1,000,000 from the Education Trust Fund to the Department of
18 Rehabilitation Services for the fiscal year ending September
19 30, 2013.

20 Section 2. In addition to all other appropriations
21 heretofore or hereafter made, there is hereby appropriated
22 \$1,000,000 from the Education Trust Fund to the Alabama
23 Institute for Deaf and Blind for the fiscal year ending
24 September 30, 2013.

25 Section 3. In addition to all other appropriations
26 heretofore or hereafter made, there is hereby appropriated
27 \$400,000 from the Education Trust Fund to the Department of

1 Archives and History for the fiscal year ending September 30,
2 2013.

3 Section 4. In addition to all other appropriations
4 heretofore or hereafter made, there is hereby appropriated
5 \$500,000 from the Education Trust Fund to the Legislature for
6 the fiscal year ending September 30, 2013.

7 Section 5. In addition to all other appropriations
8 heretofore or hereafter made, there is hereby appropriated
9 \$250,000 from the Education Trust Fund to the Public Library
10 Service for the fiscal year ending September 30, 2013.

11 Section 6. In addition to all other appropriations
12 heretofore or hereafter made, there is hereby appropriated
13 \$150,000 from the Education Trust Fund to the Alabama School
14 of Mathematics and Science for the fiscal year ending
15 September 30, 2013.

16 Section 7. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$150,000 from the Education Trust Fund to the Alabama School
19 of Fine Arts for the fiscal year ending September 30, 2013.

20 Section 8. In addition to all other appropriations
21 heretofore or hereafter made, there is hereby appropriated
22 \$430,000 from the Education Trust Fund to the Department of
23 Homeland Security for the fiscal year ending September 30,
24 2013. This appropriation shall be expended to expand active
25 shooter training and Virtual Alabama.

26 Section 9. Notwithstanding any other provisions of
27 law, any amount from appropriations for the fiscal year ending

1 September 30, 2013 to the various state agencies and
2 institutions in this bill which are unexpended and reverted on
3 September 30, 2013 are hereby reappropriated to the respective
4 agencies and institutions for the fiscal year beginning
5 October 1, 2013.

6 Section 10. This act shall become effective
7 immediately upon its passage and approval by the Governor, or
8 upon its otherwise becoming law.
