1 151672-1:n:04/09/2013:JMW/jmw LRS2013-1875 2 3 4 5 6 7 COMMENDING DEPUTY ROBERT LINDELL OF THE BALDWIN 8 COUNTY SHERIFF'S OFFICE AS A NOMINEE FOR THE 2013 ALABAMA 9 10 LEGISLATIVE MEDAL OF HONOR FOR LAW ENFORCEMENT. 11 12 WHEREAS, it is with highest commendation that we 13 recognize Deputy Robert Lindell as a nominee for the 2013 14 Alabama Legislative Medal of Honor for Law Enforcement, 15 Alabama's highest law enforcement award for extraordinary courage in the line of duty; and 16 17 WHEREAS, Deputy Lindell has been employed as a full-time Deputy Sheriff with the Baldwin County Sheriff's 18 19 Office since August 29, 2011, and currently serves in the Patrol Division of the Sheriff's Office; and 20 21 WHEREAS, on November 23, 2012, Deputy Lindell and 22 others responded to a medical assistance call near Fairhope, 23 Alabama; the subject of the call was in his residence and 24 refused to emerge to be screened by medical personnel for possible mental and emotional issues; it was believed at the 25 26 time that the subject might be of danger to himself and 27 others; and

1 WHEREAS, after several minutes of negotiations, the 2 subject fired upon the deputies from within his residence, 3 seriously injuring Deputy Scott Ward and Sergeant Curtis 4 Summerlin, both of whom were struck multiple times; Deputy 5 Lindell was able to return fire on the subject, killing him 6 during the gun battle; Deputy Lindell then immediately began 7 to render first aid to the two injured deputies; and

8 WHEREAS, Deputy Ward and Sergeant Summerlin were 9 flown by helicopter to the University of South Alabama Medical 10 Center, where Sergeant Summerlin was hospitalized and required 11 several surgeries to address his gunshot wounds; tragically, 12 Deputy Ward succumbed to the multiple gunshot wounds despite 13 every effort to save his life; and

14 WHEREAS, a comprehensive investigation was launched 15 in the immediate aftermath, and the results showed that Deputy Lindell acted without regard for his own safety and, by his 16 17 actions, saved the life of Sergeant Summerlin; Deputy Lindell went above and beyond the call of duty and acted in an 18 appropriate manner during this critical event, saving the life 19 of a fellow deputy sheriff and also preserving the safety of 20 21 the community; and

22 WHEREAS, Deputy Lindell is a brave law enforcement 23 officer and a worthy exemplar of those caring and dedicated 24 men and women who stand ever ready to provide prompt and 25 professional response in times of crisis, and he is highly 26 deserving of this distinguished nomination for the Legislative 27 Medal of Honor for Law Enforcement; now therefore,
