4 ENROLLED, An Act,

5 To make a supplemental appropriation from the
6 Education Trust Fund to the Department of Commerce in the
7 amount of \$10,800,000 for the fiscal year ending September 30,
8 2013; to make a supplemental appropriation from the Education
9 Trust Fund to the Department of Veterans' Affairs in the
10 amount of \$5,264,915 for the fiscal year ending September 30,
11 2013; to provide that any amount appropriated, for the fiscal
12 years ending September 30, 2012 and September 30, 2013, to
13 Jacksonville State University for the Alabama Film Initiative
14 Program and the Little River Canyon Field School which are
15 unexpended shall remain at Jacksonville State University to be
16 expended for the Film Initiative Program and the Little River
17 Canyon Field School; and to provide that \$2,316,462 in
18 unexpended and carried over funds for prior fiscal years that
19 were appropriated to the State Department of Education for the
20 Alabama Science in Motion Program shall remain at the State
21 Department of Education to be expended for the Alabama Science
22 in Motion Program.

23 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

24 Section 1. In addition to all other appropriations
25 heretofore or hereafter made, there is hereby appropriated

1 \$10,800,000 from the Education Trust Fund to the Department of
2 Commerce for the fiscal year ending September 30, 2013 to
3 comply with state incentive commitments for new and expanding
4 industries. This appropriation shall be expended for Workforce
5 Development in the Alabama Industrial Development Training
6 Institute Program.

7 Section 2. In addition to all other appropriations
8 heretofore or hereafter made, there is hereby appropriated
9 \$5,264,915 from the Education Trust Fund to the Department of
10 Veterans' Affairs for the fiscal year ending September 30,
11 2013. This appropriation shall be expended for the Student
12 Financial Aid Program.

13 Section 3. Notwithstanding any provision of law to
14 the contrary, any amount appropriated to Jacksonville State
15 University for the Alabama Film Initiative Program and the
16 Little River Canyon Field School, for the fiscal years ending
17 September 30, 2012 and September 30, 2013, which are
18 unexpended shall remain at Jacksonville State University to be
19 expended for the Film Initiative Program and the Little River
20 Canyon Field School.

21 Section 4. Notwithstanding any provision of law to
22 the contrary, \$2,316,462 in unexpended and carried over funds
23 appropriated from the Education Trust Fund to the State
24 Department of Education in prior fiscal years for the Alabama
25 Science in Motion Program shall remain at the State Department

1 of Education for the Alabama Science in Motion Program to be
2 expended in accordance with Title 16, Chapters 61B and 61C, of
3 the Code of Alabama 1975.

4 Section 5. This act shall become effective
5 immediately upon its passage and approval by the Governor, or
6 upon its otherwise becoming law.
