Section 3. The provisions of Section 1 shall not be effective unless approved by a majority of the electors of the City of Double Springs, a majority of the electors who reside within one and one-half mile of the property to be annexed,

1 and a majority of the electors residing on the property to be 2 annexed voting at a referendum on the annexation. The referendum shall be set by the judge of probate of the county 3 upon request of the City Council of the City of Double Springs. If the judge of probate determines there are no 5 registered voters residing on the property proposed to be 6 7 annexed, the election may be conducted by the municipality in the same manner as a municipal election or, in the 8 alternative, the election may be held in conjunction with a 9 10 regularly scheduled primary or general election. The city shall pay all costs related to the election. The question to 11 12 be presented on the ballot shall be: "Do you favor the 13 approval of Act of the 2013 Regular Session, annexing 14 property described in that act into the City of Double 15 Springs? Yes No. If a majority of the votes cast are "Yes", the annexation provided in Section 1 shall be effective 16 17 on the first day of the month following the election. If a majority of the votes cast are "No", this act shall have no 18 further effect. 19 Section 4. This act shall become effective on the 20 21 first day of the third month following its passage and

approval by the Governor, or its otherwise becoming law.
