2 ENROLLED, An Act,

3 To make an appropriation of \$196,978 from the State  
4 General Fund to the Coalition Against Domestic Violence for  
5 the fiscal year ending September 30, 2015, to require the  
6 appropriation to be distributed equally to domestic violence  
7 programs, to require an operations plan and an audited  
8 financial statement prior to the release of any funds, and to  
9 require quarterly and end of year performance reports.

10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

11 Section 1. For the fiscal year ending September 30,  
12 2015, there is hereby appropriated to the Coalition Against  
13 Domestic Violence from the State General Fund the sum of  
14 \$196,978. In addition, the appropriation made herein shall be  
15 budgeted and allotted pursuant to the Budget Management Act  
16 and Article 4 of Title 41 of the Code of Alabama, 1975, and  
17 specifically Section 41-4-93, Section 41-4-95 and Section  
18 41-4-96. The Coalition Against Domestic Violence shall  
19 distribute the appropriation made herein in equal amounts to  
20 each of its certified full member programs as of October 1,  
21 2013.

22 Section 2. Prior to the release of any funds  
23 appropriated under this bill for fiscal year 2014-2015, an  
24 operations plan for fiscal year 2014-2015 and an audited  
25 financial statement for all operations during fiscal year

1 2012-2013 must be forwarded to the Director of Finance. It is  
2 the intent to release fiscal year 2014-2015 funds following  
3 receipt of these reports.

4 Section 3. In addition, quarterly reports for fiscal  
5 year 2014-2015 shall be made to the Director of Finance  
6 relating actual expenditures and accomplishments. An end of  
7 year performance report for the fiscal year 2014-2015 shall be  
8 made to the Director of Finance stating the work accomplished  
9 and services provided and the costs of accomplishing the work  
10 and providing the services, citing meaningful measures of  
11 program effectiveness and costs, as is required for state  
12 agencies in Code of Alabama 1975, Section 41-19-11. The  
13 Director of Finance shall forward a copy of all required  
14 reports to the Joint Fiscal Committee in a timely manner.

15 Section 4. This act shall become effective October  
16 1, 2014.
