2 ENROLLED, An Act,

To alter, rearrange, and extend the boundary lines and corporate limits of the municipality of Trussville in St. Clair County.

6 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the municipality of Trussville in St. Clair County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory in St. Clair County, Alabama being more particularly described as follows:

13 The Southwest one-quarter of the Southwest 14 one-quarter of Section 2, Township 16 South, Range 1 East; the 15 South one-half of the Northeast one-quarter less the West 60 16 acres, and the Southeast one-quarter of Section 3, Township 16 17 South, Range 1 East; and the Northeast one-quarter of Section 18 10, Township 16 South, Range 1 East; St. Clair County, Alabama 19 being more particularly described as follows:

Begin at the Northeast corner of Section 10, Township 16 South, Range 1 East, St. Clair County, Alabama; thence run South 03°01'27" East, said bearing based upon the Alabama West zone, State Plane Coordinate System, along said East Section line, of said Section, for 2649.82 feet, being the Southeast corner of the Southeast one-quarter of the

south 00°33'32" West along East Section line for 1317.80 feet, 1 2 being the Southeast corner of the Southeast one-quarter of the 3 Northeast one-quarter of said Section 3; thence run South 00°23'33" West along East Section line for 1327.47 feet, being 4 5 the Southeast corner of the Northeast one-quarter of the Southeast one-quarter of said Section 3; thence run South 6 89°59'14" East along North line for 1303.37 feet, being the 7 8 Northeast corner of the Southwest one-quarter of the Southwest one-quarter of said Section 2; thence run South 01°31'01" East 9 along East line for 1330.50 feet, being the Southeast corner 10 11 of the Southwest one-quarter of the Southwest one-quarter of said Section 2; thence run North 89°40'03" West along South 12 line for 1348.88 feet, being the Southeast corner of the 13 14 Southeast one-quarter of the Southeast one-quarter of said 15 Section 3, to the POINT OF BEGINNING, containing 383.768 16 acres, more or less.

5 ALSO LESS AND EXCEPT: A parcel of land situated in the Northeast guarter of the Southeast guarter of Section 3, 6 Township 16 South, Range 1 East, St. Clair County, Alabama, 7 8 being more particularly described as follows: Commence at the Northeast corner of the Northeast guarter of the Southeast 9 10 quarter of Section 3, Township 16 South, Range 1 East; thence 11 North 88°37'22" West and run west along the north line of said quarter-quarter section 300.00 feet to the Point of Beginning 12 13 of the tract herein described; continue along said north line 14 a distance of 334.05 feet to a point on the easterly 15 right-of-way line of a 100 foot wide easement as recorded in 16 Map Book 2006, Page 477 in the Office of the Judge of Probate in St. Clair County, Alabama; thence run South 24°45'09" West 17 and run along the easterly line of said easement for 320.79 18 feet; thence South 77°21'20" West and run along the easterly 19 line of said easement for 110.25 feet; thence South 12°31'42" 20 West and run along the easterly line of said easement for 21 22 338.91 feet; thence South 88°42'17" East for 634.74 feet; 23 thence North 1°17'45" East and run a distance of 655.08 feet 24 to the Point of Beginning, containing 7.60 acres, more or 25 less.

Section 2. The parent or legal guardian of any student who, on the effective date of this act, is enrolled in the St. Clair County school system and receiving special services and resides at a location annexed by this act may elect to have the student continue to attend the St. Clair County school system or may enroll the student in the Trussville City school system.

8 Section 3. In accordance with Section 11-42-6(b) of 9 the Code of Alabama 1975, a map showing what territory is 10 proposed to be annexed to the municipality of Trussville is on 11 file in the office of the Judge of Probate in St. Clair 12 County, Alabama, and the map is open to the inspection of the 13 public.

14 Section 4. This act shall become effective on the 15 first day of the third month following its passage and 16 approval by the Governor, or its otherwise becoming law.
