8 SYNOPSIS: This bill makes a supplemental appropriation  
9 from the Enforcement Seizure Fund to the Alabama  
10 Alcoholic Beverage Control Board in the amount of  
11 \$750,000 for the fiscal year ending September 30,  
12 2014; a supplemental appropriation from the Music  
13 Hall of Fame Fund to the Alabama Music Hall of Fame  
14 Board in the amount of \$80,000 for the fiscal year  
15 ending September 30, 2014; requires a transfer of  
16 \$1,500,000 from the Office of the Attorney General  
17 to the Office of Prosecution Services for the  
18 fiscal year ending September 30, 2014; and amends  
19 appropriations made in Section 2C of Act 2013-263  
20 for the fiscal year ending September 30, 2014.

26 To make a supplemental appropriation from the  
27 Enforcement Seizure Fund to the Alabama Alcoholic Beverage

1 Control Board in the amount of \$750,000 for the fiscal year  
2 ending September 30, 2014; to make a supplemental  
3 appropriation from the Music Hall of Fame Fund to the Alabama  
4 Music Hall of Fame Board in the amount of \$80,000 for the  
5 fiscal year ending September 30, 2014; to require a transfer  
6 of \$1,500,000 from the Office of the Attorney General to the  
7 Office of Prosecution Services for the fiscal year ending  
8 September 30, 2014; and to amend appropriations made in  
9 Section 2C of Act 2013-263 for the fiscal year ending  
10 September 30, 2014.

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

12 Section 1. In addition to all other appropriations  
13 heretofore or hereafter made, there is hereby appropriated  
14 \$750,000 from the Enforcement Seizure Fund to the Alabama  
15 Alcoholic Beverage Control Board for the fiscal year ending  
16 September 30, 2014.

17 Section 2. In addition to all other appropriations  
18 heretofore or hereafter made, there is hereby appropriated  
19 \$80,000 from the Music Hall of Fame Fund to the Alabama Music  
20 Hall of Fame Board for the fiscal year ending September 30,  
21 2014.

22 Section 3. In addition to all other appropriations  
23 heretofore or hereafter made, the Office of the Attorney  
24 General shall transfer \$1,500,000 to the Office of Prosecution  
25 Services from the funds received pursuant to the National  
26 Mortgage Settlement for the fiscal year ending September 30,  
27 2014.

1                   Section 4. In addition to all other appropriations  
2 heretofore or hereafter made, \$1,500,000 of the appropriation  
3 made within the Court Operations Program of the Office of  
4 Prosecution Services in Section 2C of Act 2013-263 shall  
5 consist of a transfer from the Office of the Attorney General  
6 from funds received from the National Mortgage Settlement.  
7 This appropriation shall be distributed to the District  
8 Attorney's Office in each Judicial Circuit in proportion to  
9 the State General Fund allocations to those offices made in  
10 Act 2013-263. This appropriation must be used for costs of  
11 investigation and litigation of law enforcement efforts to  
12 prevent and prosecute financial fraud and/or for public  
13 protection services.

14                   Section 5. This act shall become effective  
15 immediately upon its passage and approval by the Governor, or  
16 upon its otherwise becoming law.
