Section 2. In accordance with Section 11-42-6(b) of the Code of Alabama 1975, a map showing what territory is proposed to be annexed to the City of Alabaster is on file in the office of the Judge of Probate in Shelby County, Alabama, and the map is open to the inspection of the public.

21 Section 3. This act shall become effective 22 immediately following its passage and approval by the 23 Governor, or its otherwise becoming law.
