  During the 90-day period, the owner or owners of property that is included in the description in subsection (a) to be annexed may request in writing to the city clerk to be excluded from the annexation if the property is classified for ad valorem tax purposes as Class III property and not in a platted subdivision."
  - Section 2. The provisions of this act are curative to make technical corrections in the description in  $\operatorname{Act}$  2015-332.
  - Section 3. In accordance with Section 11-42-6(b) of the Code of Alabama 1975, a map showing what territory is proposed to be annexed to the City of Jacksonville is on file in the office of the Judge of Probate in Calhoun County, Alabama, and the map is open to the inspection of the public.

Section 4. This act shall become effective immediately following its passage and approval by the Governor, or its otherwise becoming law.
