3 Section 2. Prior to the release of any funds 4 appropriated under this bill for fiscal year 2015-2016, an 5 operations plan for fiscal year 2015-2016 and an audited 6 financial statement for all operations during fiscal year 7 2013-2014 must be forwarded to the Director of Finance. It is 8 the intent to release fiscal year 2015-2016 funds following 9 receipt of these reports.

10 Section 3. In addition, quarterly reports for fiscal 11 year 2015-2016 shall be made to the Director of Finance 12 relating actual expenditures and accomplishments. An end of year performance report for the fiscal year 2015-2016 shall be 13 14 made to the Director of Finance stating the work accomplished 15 and services provided and the costs of accomplishing the work and providing the services, citing meaningful measures of 16 17 program effectiveness and costs, as is required for state agencies in Code of Alabama 1975, Section 41-19-11. The 18 19 Director of Finance shall forward a copy of all required reports to the Joint Fiscal Committee in a timely manner. 20
