26	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1 Section 1. For the fiscal year ending September 30, 2 2016, there is hereby appropriated to the Coalition Against Domestic Violence from the State General Fund the sum of 3 4 \$196,978. In addition, the appropriation made herein shall be budgeted and allotted pursuant to the Budget Management Act 5 and Article 4 of Title 41 of the Code of Alabama, 1975, and 6 7 specifically Section 41-4-93, Section 41-4-95 and Section 41-4-96. 8

9 Section 2. Prior to the release of any funds 10 appropriated under this bill for fiscal year 2015-2016, an 11 operations plan for fiscal year 2015-2016 and an audited 12 financial statement for all operations during fiscal year 13 2013-2014 must be forwarded to the Director of Finance. It is 14 the intent to release fiscal year 2015-2016 funds following 15 receipt of these reports.

Section 3. In addition, quarterly reports for fiscal 16 17 year 2015-2016 shall be made to the Director of Finance relating actual expenditures and accomplishments. An end of 18 19 year performance report for the fiscal year 2015-2016 shall be made to the Director of Finance stating the work accomplished 20 21 and services provided and the costs of accomplishing the work 22 and providing the services, citing meaningful measures of 23 program effectiveness and costs, as is required for state agencies in Code of Alabama 1975, Section 41-19-11. The 24 Director of Finance shall forward a copy of all required 25 26 reports to the Joint Fiscal Committee in a timely manner.
