ENROLLED, An Act,

To alter, rearrange, and extend the boundary lines and corporate limits of the municipality of Hayden in Blount County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the municipality of Hayden in Blount County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

Tract I

Part of the W 1/2 of the NW 1/4 and part of the NW 1/4 of the SW 1/4 of Section 16, Township 13 South Range 3 West, Blount County Alabama described as follows:

From the Northeast corner of the NW 1/4 of the NW 1/4 of said Section, run south 0 degrees 11' East along the 1/4 mile line 1184.0 feet to a pipe on the Southeast right of way of a county highway, the point of beginning; thence continue South 0 degrees 11' East 1713.5 feet to a pipe at the foot of a hill; thence Northwesterly along the foot of hill as follows:

North 52 degrees 24' West 121.6 feet; thence North 75 degrees 28' West. 102.3 feet; thence North 85 degrees 07' West 82.3 feet to a pipe on the Northeast right of way of

1 Interstate Highway No. 65; thence Northwesterly along the arc
2 of a curve which has a radius of 11309.2 feet, concave
3 Northeasterly and a chord which bears North 14 degrees 47'
4 West 610.9 feet a distance of 611.0 feet to a concrete
5 monument marked "408+00"; thence continue along the right of
6 way of said highway, North 0 degrees 12' East 733.8 feet to a
7 concrete monument marked "92+60"; thence along the right of
8 way of county highway, North 63 degrees 12' East, 339.7 feet
9 to concrete monument marked "96+00"; thence North 28 degrees
10 03' West 60.1 feet to a concrete monument; thence North 63
11 degrees 12' East, continuing along the right of way of the
12 County Highway 168.2 feet to the point of beginning containing
13 13 acres more or less.

9 Parcel II

10 The NW 1/4 of the NW 1/4 of Section 25 Township 13,
11 Range 2 West situation in Blount County Alabama Containing 40
12 acres more or less.

13 Parcel III

14 The NE 1/4 of the SW 1/4 of Section 25 Township 13,
15 Range 2 West situation in Blount County Alabama Containing 40
16 acres more or less.

17 Section 2. In accordance with Section 11-42-6(b) of
18 the Code of Alabama 1975, a map showing what territory is
19 proposed to be annexed to the municipality of Hayden is on
20 file in the office of the Judge of Probate in Blount County,
21 Alabama, and the map is open to the inspection of the public.

22 Section 3. This act shall become effective on the
23 first day of the third month following its passage and
24 approval by the Governor, or its otherwise becoming law.
