9 A BILL
10 TO BE ENTITLED
11 AN ACT
12

13 To alter, rearrange, and extend the boundary lines
14 and corporate limits of the municipality of Hayden in Blount
15 County.

16 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

17 Section 1. The boundary lines and corporate limits
18 of the municipality of Hayden in Blount County are altered,
19 rearranged, and extended to include within the corporate
20 limits of the municipality, in addition to the lands now
21 included, all of the following territory:

22 Tract I

23 Part of the W 1/2 of the NW 1/4 and part of the NW
24 1/4 of the SW 1/4 of Section 16, Township 13 South Range 3
25 West, Blount County Alabama described as follows:

26 From the Northeast corner of the NW 1/4 of the NW
27 1/4 of said Section, run south 0 degrees 11' East along the

1 1/4 mile line 1184.0 feet to a pipe on the Southeast right of
2 way of a county highway, the point of beginning; thence
3 continue South 0 degrees 11' East 1713.5 feet to a pipe at the
4 foot of a hill; thence Northwesterly along the foot of hill as
5 follows:

6 North 52 degrees 24' West 121.6 feet; thence North
7 75 degrees 28' West. 102.3 feet; thence North 85 degrees 07'
8 West 82.3 feet to a pipe on the Northeast right of way of
9 Interstate Highway No. 65; thence Northwesterly along the arc
10 of a curve which has a radius of 11309.2 feet, concave
11 Northeasterly and a chord which bears North 14 degrees 47'
12 West 610.9 feet a distance of 611.0 feet to a concrete
13 monument marked "408+00"; thence continue along the right of
14 way of said highway, North 0 degrees 12' East 733.8 feet to a
15 concrete monument marked "92+60"; thence along the right of
16 way of county highway, North 63 degrees 12' East, 339.7 feet
17 to concrete monument marked "96+00"; thence North 28 degrees
18 03' West 60.1 feet to a concrete monument; thence North 63
19 degrees 12' East, continuing along the right of way of the
20 County Highway 168.2 feet to the point of beginning containing
21 13 acres more or less.

9 page 334, in the Office of Judge of Probate, Blount County
10 Alabama.

11 Tract III

12 Parcel I

13 The NE 1/4 of NE 1/4 of Section 3 Township 14 Range
14 2 West Blount County Alabama containing 40 acres more or less.

15 Parcel II

16 The NW 1/4 of the NW 1/4 of Section 25 Township 13,
17 Range 2 West situation in Blount County Alabama Containing 40
18 acres more or less.

19 Parcel III

20 The NE 1/4 of the SW 1/4 of Section 25 Township 13,
21 Range 2 West situation in Blount County Alabama Containing 40
22 acres more or less.

23 Section 2. In accordance with Section 11-42-6(b) of
24 the Code of Alabama 1975, a map showing what territory is
25 proposed to be annexed to the municipality of Hayden is on
26 file in the office of the Judge of Probate in Blount County,
27 Alabama, and the map is open to the inspection of the public.

1 Section 3. This act shall become effective on the
2 first day of the third month following its passage and
3 approval by the Governor, or its otherwise becoming law.
