4 ENROLLED, An Act,

5 To make a supplemental appropriation from the  
6 Education Trust Fund to the Legislature in the amount of  
7 \$1,410,551 for the fiscal year ending September 30, 2015; to  
8 make a supplemental appropriation from the Education Trust  
9 Fund to the Department of Human Resources in the amount of  
10 \$3,000,000 for the fiscal year ending September 30, 2015; and  
11 to make a supplemental appropriation from the Education Trust  
12 Fund to the Department of Veterans' Affairs in the amount of  
13 \$2,663,775 for the fiscal year ending September 30, 2015.

14 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

15 Section 1. In addition to all other appropriations  
16 heretofore or hereafter made, there is hereby appropriated  
17 \$1,410,551 from the Education Trust Fund to the Legislature  
18 for the fiscal year ending September 30, 2015.

19 Section 2. In addition to all other appropriations  
20 heretofore or hereafter made, there is hereby appropriated  
21 \$2,663,775 from the Education Trust Fund to the Department of  
22 Veterans' Affairs for the fiscal year ending September 30,  
23 2015. This appropriation shall be expended for the Student  
24 Financial Aid Program.

1           Section 3. In addition to all other appropriations  
2 heretofore or hereafter made, there is hereby appropriated  
3 \$3,000,000 from the Education Trust Fund to the Department of  
4 Human Resources for the fiscal year ending September 30, 2015.  
5 This appropriation shall be expended for the program created  
6 by the Fostering Hope Scholarship Act of 2015.

7           Section 4. In addition to all other appropriations  
8 heretofore or hereafter made, there is hereby appropriated  
9 \$200,000 from the Education Trust Fund to the Alabama  
10 Commission on Higher Education for the Articulation and  
11 General Studies Committee (AGSC)/Statewide Transfer and  
12 Articulation Reporting System (STARS) for the fiscal year  
13 ending September 30, 2015.

14           Section 5. The appropriation from the Education  
15 Trust Fund made in Act 2014-456 to the Department of Finance  
16 for payments for unused sick leave pursuant to Section  
17 16-1-18.2, Code of Alabama 1975, is hereby reduced by \$200,000  
18 for the fiscal year ending September 30, 2015.

19           Section 6. This act shall become effective  
20 immediately upon its passage and approval by the Governor, or  
21 upon its otherwise becoming law.
