8 SYNOPSIS: This bill makes a supplemental appropriation  
9 from the Education Trust Fund to the Legislature in  
10 the amount of \$1,410,551 for the fiscal year ending  
11 September 30, 2015; makes a supplemental  
12 appropriation from the Education Trust Fund to the  
13 Department of Veterans' Affairs in the amount of  
14 \$2,663,775 for the fiscal year ending September 30,  
15 2015; and makes a supplemental appropriation from  
16 the Education Trust Fund to the Department of Human  
17 Resources in the amount of \$3,000,000 for the  
18 fiscal year ending September 30, 2015.

24 To make a supplemental appropriation from the  
25 Education Trust Fund to the Legislature in the amount of  
26 \$1,410,551 for the fiscal year ending September 30, 2015; to  
27 make a supplemental appropriation from the Education Trust

1 Fund to the Department of Human Resources in the amount of  
2 \$3,000,000 for the fiscal year ending September 30, 2015; and  
3 to make a supplemental appropriation from the Education Trust  
4 Fund to the Department of Veterans' Affairs in the amount of  
5 \$2,663,775 for the fiscal year ending September 30, 2015.

6 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

7 Section 1. In addition to all other appropriations  
8 heretofore or hereafter made, there is hereby appropriated  
9 \$1,410,551 from the Education Trust Fund to the Legislature  
10 for the fiscal year ending September 30, 2015.

11 Section 2. In addition to all other appropriations  
12 heretofore or hereafter made, there is hereby appropriated  
13 \$2,663,775 from the Education Trust Fund to the Department of  
14 Veterans' Affairs for the fiscal year ending September 30,  
15 2015. This appropriation shall be expended for the Student  
16 Financial Aid Program.

17 Section 3. In addition to all other appropriations  
18 heretofore or hereafter made, there is hereby appropriated  
19 \$3,000,000 from the Education Trust Fund to the Department of  
20 Human Resources for the fiscal year ending September 30, 2015.  
21 This appropriation shall be expended for the program created  
22 by the Fostering Hope Act of 2015.

23 Section 4. This act shall become effective  
24 immediately upon its passage and approval by the Governor, or  
25 upon its otherwise becoming law.
