6 WITHIN THE CITY OF SATSUMA, ALABAMA, THE CHARLES LITTLE  
7 BOULEVARD.

9 WHEREAS, The City of Satsuma suffered a great loss  
10 on March 7, 2014, when former Mayor Charles Little passed  
11 away; and

12 WHEREAS, Charles Little served with distinction as a  
13 City Council member for 12 years beginning in 1968 and in 1980  
14 was elected as Mayor and served for 16 years; and

15 WHEREAS, Charles Little was the longest serving  
16 elected official in Satsuma history; and

17 WHEREAS, during his service as mayor for the City,  
18 Mayor Little worked to create the City Seal, expand the  
19 boundaries of the City, and improve parks and was instrumental  
20 in getting many roads paved. Charles Little was a man of honor  
21 and served as a Southern Gentleman. His efforts to improve the  
22 City, most notably the installation of a sewer system, were  
23 invaluable to the growth of the City; and

1           WHEREAS, U.S. Highway 43 runs through the heart of  
2 the City of Satsuma and is well traveled by citizens and  
3 visitors alike; and

4           WHEREAS, it would be a fitting memorialization of  
5 Charles Little's contributions to the City of Satsuma if the  
6 section of U.S. Highway 43 within the City of Satsuma,  
7 Alabama, were named for him; now therefore,

8           BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
9 HOUSES THEREOF CONCURRING, That in honor of Mayor Charles  
10 Little, we declare that the portion of U.S. Highway 43 within  
11 the City of Satsuma, Alabama, be named the "Charles Little  
12 Boulevard."

13           BE IT FURTHER RESOLVED, That the appropriate  
14 officials be requested to place and maintain signs or markers  
15 as provided in this resolution.
