COMMENDING THE HONORABLE GEORGETTE WHITE MOON FOR
OUTSTANDING PUBLIC SERVICE ON THE TUSKEGEE CITY COUNCIL.

WHEREAS, highest commendations are herein proudly
presented to City Councilwoman Georgette White Moon for
outstanding public service on the Tuskegee City Council on the
occasion of her retirement in 2016; and

WHEREAS, first elected to the Tuskegee City Council
in 2004, City Councilwoman Georgette White Moon has
demonstrated an unwavering commitment to credibility,
integrity, and accountability while representing District 3
during her consecutive four-year terms of leadership; and

WHEREAS, her service has been marked by remarkable
downtown improvements, the development of Washington Plaza
Shopping Center, an increased number of retail stores,
increased sales tax revenues, property abatement in several
neighborhoods, the establishment of Greenfork Playground, the
paving of streets in Greenfork, Gauthier, and Church Street
neighborhoods, drainage project at Freeman Plaza, and her

9 earned numerous accolades including Teacher of the Year
10 Selection at Cora Kelly Magnet School in Alexandria, Virginia,
11 Team Teacher of the Year selection, Macon County Teacher of
12 the Year selection, Math and Science Teacher of the Year
13 selection, Iota Phi Lambda Outstanding Teacher of the Year
14 selection, and the Tuskegee Graduate Chapter Community Service
15 Award; and

16 WHEREAS, City Councilwoman Moon holds a Bachelor's
17 Degree from Alabama State University and a Master's Degree
18 from Michigan State University and pursued post-graduate
19 studies at Tuskegee University; she is an active member of the
20 Alpha Kappa Alpha Sorority, Inc., and of the Friends of the
21 Tuskegee Airmen National Historic Site and a faithful and
22 dedicated member of Bethel Baptist Church; and

23 WHEREAS, through the years, City Councilwoman Moon
24 has earned immense respect for her tireless dedication and
25 exceptional abilities; her unwavering commitment to excellence

1 in public service reflects immense credit upon Tuskegee and
2 the entire State of Alabama, and she is truly deserving of
3 special commendation and praise; now therefore,

6 Moon is honored and commended, and this resolution is offered
