16	business, industry, and state and local governmental entities;

18	WHEREAS, the EPA proposed rules related to		
19	administratively extending permits are vague and not		
20	authorized by the Clean Water Act; and		
21	WHEREAS, these rules will adversely impact the		
22	ability of delegated states to manage NPDES permits as		
23	authorized by the Clean Water Act; and		

1	WHEREAS, the additional requirement for delegated
2	states with regard to record keeping will impose an undue
3	burden on the states with no additional revenue; and
4	WHEREAS, EPA mandated changes in calculations used
5	by delegated states will reduce the flexibility state
6	regulators need to account for local conditions; and
7	WHEREAS, the EPA failed to engage state regulators
8	and other parties in meaningful collaborations on these NPDES
9	issues; now therefore,
10	BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH

12	immediately withdraw EPA-HQ-OW-2016-0145.
