27	for the purposes of the federal Supplemental Nutrition

Assistance Program regardless of where or by what means food is sold. In the event that the federal Supplemental Nutrition Assistance Program definition no longer exists, the Legislature shall provide a new definition of food by general law.

6 (2) SALES TAX. The tax levied in Section 40-23-2,
7 Code of Alabama 1975, on the gross sales or gross receipts
8 from the sale of tangible personal property.

9 (3) USE TAX. The tax levied in Section 40-23-61,
10 Code of Alabama 1975, on the storage, use, or other
11 consumption of tangible personal property in Alabama.

12 Section 2. Notwithstanding any other provision of 13 law, for taxable periods beginning on and after September 1, 14 2016, the gross receipts from the sale or use of food shall be 15 exempt from the state sales and use taxes. Local governments 16 shall continue to collect sales taxes on food at the same rate 17 collected for the local portion of the retail sales tax.

Section 3. This act shall become effective immediately following its passage and approval by the Governor, or its otherwise becoming a law.
