18	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
19	Section 1. Section 45-36-162, Code of Alabama 1975,
20	is amended to read as follows:
21	<b>"</b> §45-36-162.
22	"Any payments coming into the treasury of Jackson
23	County that are derived, directly or indirectly, from payments
24	by the Tennessee Valley Authority in lieu of payment of taxes
25	shall be appropriated as follows:
26	"(1) One percent to the Jackson County Economic
27	Development Fund paid to the fund monthly until it reaches a

1	balance of one million dollars (\$1,000,000); the payments
2	shall continue whenever the balance in the fund drops below
3	one million dollars (\$1,000,000). The county commission may
4	invest the funds to the benefit of local governments and
5	entities in the county, in its discretion, and expend the same
6	for disaster relief in the county or for any economic purpose
7	that benefits the county, including, but not limited to, any
8	activity or purpose which provides an incentive for the
9	creation or retention of jobs and employment opportunities in
10	the county; participating local governments or entities may
11	apply for the funds for these purposes. It is the intent of
12	this appropriation for the Jackson County Economic Development
13	Fund to be used for recruiting industry; matching public or

"(2)(4) After the above appropriation to the Jackson
County Hospital Board, the next one hundred five thousand
dollars (\$105,000) shall be paid to the Jackson County
Economic Development Authority on an annual basis. The
appropriation shall be paid before all other appropriations
other than the appropriation to the hospital board.

7 "(3)(5) In addition to all other amounts hereinabove paid to the Jackson County Economic Development Authority, as 8 provided above, the next seventy-five thousand dollars 9 10 (\$75,000), after the appropriations in subdivisions (1) and 11 (2) shall be annually paid to the authority. All 12 appropriations made in this subdivision to the Jackson County 13 Economic Development Authority shall be deposited in a special industrial development fund to be used only for the purposes 14 of this subdivision as follows: For recruiting industry; 15 16 matching public or private grants the county may receive for 17 industrial development; and special projects for site 18 preparation, surveying, archaeological or geotechnical 19 studies, or other direct expenses necessary to recruit 20 industry to the county.

21 "(4)(6) After the above appropriation, all Jackson 22 County volunteer fire departments in good standing with the 23 Jackson County Association of Volunteer Fire Departments shall 24 be authorized to receive five thousand dollars (\$5,000) seven 25 <u>thousand five hundred dollars (\$7,500)</u> each annually to help 26 furnish adequate fire protection in the communities that they 27 serve. The amount paid to each volunteer fire department shall be paid at the direction of the county fire marshal and disbursed to each fire chief upon approval of the county fire marshal. In addition to the above, thirty thousand dollars (\$30,000) thirty-five thousand dollars (\$35,000) shall be distributed to the Jackson County Association of Volunteer Fire Departments for use by the association.

7 "(5) After the above appropriation, the next
8 twenty-five thousand dollars (\$25,000) of each year's payments
9 shall be distributed to the Scottsboro-Jackson County Rescue
10 Squad for the maintenance and operation of the rescue squad's
11 equipment and facilities.

12 "(7) The next forty thousand dollars (\$40,000) to 13 the Greater Jackson County Chamber of Commerce to promote 14 tourism, workforce development and education, and retail and 15 commercial development that promotes economic development in 16 the area. The funds disbursed pursuant to this subdivision 17 shall be disbursed in two payments of twenty thousand dollars 18 (\$20,000).

19 "(6) (8) An annual accounting of the use of the funds 20 appropriated in subdivisions (1), (2), (3), (4), and (5), (6), and (7) shall be furnished to the Jackson County Discretionary 21 22 Committee Commission no later than September 30 of each year. In the event an annual accounting is not furnished, the 23 24 committee commission may reduce or terminate funding for the 25 next fiscal year for the entity failing to furnish the report 26 by a majority vote of the <del>committee</del> commission. All resulting

1 <u>excess money shall then be transferred to the general fund of</u> 2 the county.

3 "(7)(9) Commencing October 1, 2013 2016, the net
4 payments remaining in the appropriation paid to Jackson County
5 after the appropriations in subdivisions (1), (2), (3), (4),
6 and (5), (6), and (7) shall be appropriated as follows:

7 "a. Two percent of such payments, as shall be 8 necessary, shall be used to establish, equip, and maintain a legislative office for the members of the state legislative 9 10 delegation serving Jackson County, Alabama, and any unused portion shall be paid to the Jackson County Discretionary Fund 11 12 to be disbursed by the Jackson County Discretionary Committee, 13 as established hereinafter, in the same manner as all other funds from the Jackson County Discretionary Fund Commission's 14 15 general fund.

16 "b. Two percent of such payments shall be17 appropriated to Jackson County EDA under this section.

18 "c. Thirty-three and fifty hundredths <u>Thirty-six</u> 19 percent of such payments shall be appropriated to the public 20 school systems within Jackson County on a per pupil pro rata 21 basis.

"d. Twenty-five <u>Twenty-nine</u> and fifty hundredths
percent of such payments shall be appropriated to the
incorporated municipalities within the county on a population
basis.

"e. Twenty-five and fifty hundredths percent of such 1 2 payments shall be placed in the general fund of the county treasury and may be used for any lawful purpose by the county. 3 "f. Eleven e. Thirty and fifty hundredths percent of 4 such payments shall be placed in a Jackson County 5 Discretionary Fund to be disbursed by the Jackson County 6 7 Discretionary Committee, as established hereinafter the general fund of the county treasury and may be used for any 8 lawful purpose by the county. 9 10 "(8) There is created a Jackson County Discretionary 11 Committee consisting of six members. The members of the 12 committee shall be: The Chair of the Jackson County 13 Commission, a member of the Jackson County Commission selected by the commission on an annual basis, the Jackson County 14 15 Revenue Commissioner, the state senator representing Jackson County, and the two state House of Representatives members 16 17 representing all or part of Jackson County. The state senator 18 representing Jackson County shall be the chair of the 19 committee. The discretionary committee shall adopt rules of 20 procedure consistent with this section and shall make, by 21 majority vote, all decisions concerning disbursement from the 22 Jackson County Discretionary Fund." 23 Section 2. This act shall become effective following

24 its passage and approval by the Governor, or its otherwise 25 becoming law.
