ENROLLED, House Joint Resolution,
TO EXTEND THE JOINT COMMITTEE ON ALABAMA PUBLIC
PENSIONS TO APRIL 1, 2016.

WHEREAS, House Joint Resolution 288 enacted as Act
2015-489 in the 2015 Regular Session of the Alabama
Legislature created the Joint Committee on Alabama Public
Pensions to study and develop consensus recommendations
concerning the benefits, investments, and funding of the
state-administered retirement systems and any other measures
that the committee believes would lead to the improved
financial stability of the state-administered retirement
systems including retiree health insurance benefits to
determine any future measures to ensure stability of the state
health insurance programs; and

WHEREAS, it provided that the committee would submit
findings, recommendations, and any proposed legislation to the
Legislature within in the first five days of the 2016 Regular
Session at which time the committee would be dissolved; and

WHEREAS, following the enactment of House Joint
Resolution 288, two subsequent special sessions of the
Legislature delayed the joint committee from commencing its
monthly meetings; and

1 WHEREAS, due to delays associated with two special
2 sessions, and an acknowledgement of the complexity of the
3 subject matter, the joint committee finds it appropriate to
4 seek an extension of time for its study of the public pensions
5 and health insurance programs of the State of Alabama, and
6 extending the deadline for submission of the findings of the
7 committee; and

8 WHEREAS, the committee needs an extension of time in
9 order to hold additional meetings in the months of February
10 and March of 2016. After those meetings, the committee shall
11 submit its findings, recommendations, and any proposed
12 legislation to the Legislature on or before April 1, 2016, at
13 which time it shall stand dissolved; now therefore,

14 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
15 HOUSES THEREOF CONCURRING, That the Joint Committee on Alabama
16 Public Pensions, created pursuant to Act 2015-489, HJR288, of
17 the 2015 Regular Session, is extended to April 1, 2016.
